 - An update was provided on the North Bend City Council meeting that City Administrator Mike Chambless and Mayor Ross attended last week.
 - An update was provided on the Association of Washington Cities Action Days event that CM Christensen and Mayor Ross attended last week. There were speakers from the Office of Financial Management, Attorney General, State Auditor, and lobbyists. CM Christensen and Mayor Ross met with legislatures in the 5th and 12th districts, and covered Council priorities, including Community Center funding support to ensure the youth recreational facilities program grant for the YMCA. They also spoke to SR 18 funding for the final phase, and additional types of revenues available for cities such as State sales tax revenue sharing for the project.
 - 400 to 500 people from around the globe attended the Twin Peaks events this past weekend and today. Thank you to the Twin Peaks Board who planned and hosted the event.
 - There are two upcoming climate planning workshops that will provide input for the Climate Element of the Comprehensive Plan.
