

RESOLUTION R2025-40

A RESOLUTION APPROVING A STREET NAME CHANGE FOR A STREET LOCATED WITHIN SOUTH JORDAN CITY.

WHEREAS, the City of South Jordan experienced an unfortunate accident that has had significant impact on many members of the community, and

WHEREAS, the accident that occurred on November 6, 2024 resulted in the death of 15 year old Logan Hansen, and

WHEREAS, many members of the community have expressed a desire to remember Logan and have circulated a petition to residents residing on 3210 West Street between 10540 South and 10950 South in South Jordan City; and

WHEREAS, the petition requests that the City file an Affidavit of Street Name Change with the Salt Lake County Recorder's Office adding the alphabetic name "Logan Lane" to the existing numerical name in remembrance of Logan Hansen; and

WHEREAS, the City Council finds that adding the street name in accordance with the community's request will enhance the public health, safety and general welfare, of the residents of the City of South Jordan.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF SOUTH JORDAN CITY, STATE OF UTAH:

Section 1. Street Name Change. The South Jordan City Council hereby approves and adopts the proposed street name 3210 West "Logan Lane", and directs City Staff to file appropriate documentation with Salt Lake County to reflect the updated street name.

Section 2. Severability. If any section, clause or portion of this Resolution is declared invalid by a court of competent jurisdiction, the remainder shall not be affected thereby and shall remain in full force and effect.

Section 3. Effective Date. This Resolution shall become effective immediately upon its passage.

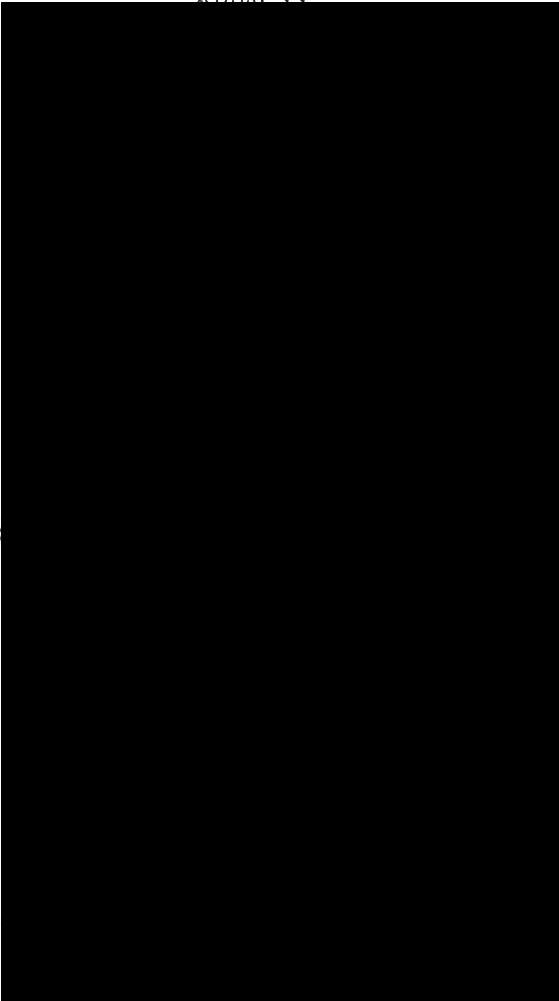
