

Briefly explain why you would like to serve on the City Committee: Being a black women myself, raising a 13 year black male, I feel it is my duty to assist in any way I can in bringing awareness and understanding to cultural inequality, implicit bias, stigma and racial stereotypes, within our beautiful yet small rural community. My hope is that through awareness and understanding and lived experiences, I can assist with making this community safer for myself, my son, my brothers, nephews, uncles and others like him.
