SUBJECT:	FY 2020-2021 City of Sonora Street Striping Project; Bid Receipt Report and Recommendation to Award a Construction Contract

### RECOMMENDATION

Consideration to receive the Bid Receipt Report for the FY 20-21 Striping Project, award the construction contract to Central Striping Services, Inc. in the amount of the total base Bid price of thirty-nine thousand one hundred ninety dollars and fifty-eight cents (\$39,190.58) and authorize the City Administrator to execute the agreement.

## DISCUSSION

On August 27, 2021, the City received two bids on the FY 2020-21 City of Sonora Street Striping Project. The project was authorized to go to bid at the August 03, 2020 City Council meeting and legal advertisements were published in the Union Democrat newspaper on August 14 and 21, 2020 for bid receipt date of August 27, 2020. The project was also advertised for bid on the City of Sonora website( <a href="https://www.sonoraca.com/city-services/bids/">https://www.sonoraca.com/city-services/bids/</a> )and direct email contact was made with 6 prospective striping contractors and various builders exchanges.

Two bids were received as follows:	Total Base Bid
a. Central Striping Services, Inc., Rancho Cordova CA	\$39,190.58
b. Chrisp Company, Stockton, CA	\$44,701.07

Attached to this report is a copy of City Clerk's Certification of Bid Opening and a Bid Results spreadsheet with the Engineers Estimate. Central Striping Services, Inc. was the low bidder on this project.

#### **Project Description:**

The project consists of the longitudinal thermoplastic striping of approximately 4.5 miles of City streets. Striping includes 4" double yellow centerline, 4" white fog lines or lane lines and 8" white channelization lines. Streets included in this project are Stewart St, Sanquinetti Rd, Wards Ferry Rd, Lyons St, Cemetery Ln, Morning Star Drive, Shaws Flat Rd and Saratoga Road.

## **Project Schedule:**

This project was bid as a fill in project for this heavy construction season with a loose schedule to get a competitive price. The project is intended to be done in the fall of this year, weather permitting, or scheduled for the spring of next year.

## **FISCAL IMPACT**

This project is budgeted under accumulated Gas Tax Funding and SB1 Road Maintenance and Rehabilitation funding of which approximately \$300,000 is available. The remainder of the funding will be put towards other striping materials, and a major pavement rehabilitation project to be done this next spring. We need to seek more funding for paving projects as our needs outweigh available funding.
