
- Request from lodging businesses for the City of Sonora to support the tourism industry by allowing for a self-assessment




Tourism Marketing Districts

- Reliability Management District Plan
- Pass-through to guest


Proposed TMD Parameters



- 5-year term
- All lodging in City & County
- City & County to individually collect/remit assessment from respective lodging
- 1% assessment
 - VTC may increase annually by 0.5%
 - Maximum of 2%

Assessment	Estimated Annual TMD Budget	Estimated from Sonora
1%	\$746,000	\$51,000
1.5%	\$1,119,000	\$77,000
2%	\$1,493,000	\$154,000

Sales & Marketing

- Strategic Promotion: Partner with organizations to market Tuolumne County globally.
- Advertising & Digital Presence: Use online, print, and broadcast media to drive tourism.
- Sales & Lead Generation: Attend trade shows, conduct sales blitzes, and develop marketing collateral.

Destination Development & Visitor Services

- Visitor Engagement: Expand visitor information, services, and data tracking.
- Wayfinding & Accessibility: Improve signage and gateway navigation.
- Sustainable Tourism: Promote responsible visitor behavior and long-term tourism growth.

GOVERNANCE

OWNERS' ASSOCIATION

Visit Tuolumne County

The Owners' Association is charged with managing funds and implementing programs in accordance with the Management District Plan and must provide annual reports to the Board of Supervisors.

OVERSIGHT

City of Sonora

The City would grant consent to the County to be included in the TMD. The City would also collect the assessment from City lodging and pass along to VTC to manage funds.

Tuolumne County

As the lead jurisdiction, the County serves in an oversight role for the TMD in collecting the assessment from County lodging and receiving the TMD's annual report.
