BACKGROUND:

Tourism plays a vital role in the economic vitality of the City of Sonora, Tuolumne County, and the surrounding Mother Lode Region. Visitors support local businesses, restaurants, lodging establishments, retail shops, cultural attractions, and recreational destinations, generating revenue and employment opportunities throughout the community.
