## DISCUSSION

For the month of August 2021, the City of Sonora Public Works Department performed the following activities:

### Events

- Placed banners above Washington Street for upcoming events.
- Deployed changeable message signs, staged road closed, and pedestrian signs and cones, in preparation for Magic of the night.
- Assisted Police and Fire Departments during the Washington Fire with traffic control and road closures.

### Streets

- Removed graffiti from restrooms at Rotary Park.
- Repaired damaged stop sign on East Bald Mt Road.
- Removed and disposed two deceased deer from City streets.
- Continued with annual weed abatement program on City streets, in landscapes, and in cemeteries.
- Clearance pruning of numerous trees on Morningstar Drive.
- Spent several days removing leaf piles on City streets.
- Spent several days straightening street signs throughout the City.
- Spent several days' potholing City streets.
- Performed roadside trash pickup on several City streets.
- Made repairs to damaged handrail on sidewalk on Barretta Street.
- Loaded and hauled pay piles in various locations throughout City.
- Removed several large hazardous China Trees on Theall Street.
- Installed no parking and red curb markings in front of a resident's stairway on North Stewart Street.
- Removed dead Sycamore Tree on Lyons Street.

### Facilities

- Replaced support post on porch at future shelter on Stewart Street.

### **Parks/Landscapes/Parking Lots**

- Removed large downed limb at Coffill Park.
- Weed wacked and pruned trees in landscape on Sanguinetti Road.

### **Storm Drains**

- Removed large downed tree in creek near Rotary Park.

### **Cemeteries**

- Prepared required monthly reports, installed headstones, checked messages daily, and returned phone calls.
- Filled several sunken plots at Mountain Shadow Cemetery.
- Removed large downed tree at Old City Cemetery.
- Spent several days weed wacking around head stones at Mountain Shadow Cemetery.

### **Miscellaneous**

- Performed routine daily and monthly activities including regular checking of parks and landscape areas for maintenance needs and safety concerns, garbage collection at City facilities, cleaning and stocking City restrooms, opening of gate to Dragoon Gulch Trail parking lot, routine maintenance of City vehicles, participation on assigned committees, weekly mowing of lawns at Mt Shadow Cemetery and Rotary Park, and weekly sweeping of City Streets.
