**SUBJECT:** S. Green St. Parking Designation

#### RECOMMENDATION

Consideration of request from Jeffrey Michels to dedicate parking on South Green Street to 15 minute parking for Hotel Lumberjack registration. Commission recommended a loading zone with review in three (3) months.

#### **DISCUSSION**

On September 16, 2021, Jeffrey Michels stated:

"We would like for the City to kindly consider transferring the two spaces adjacent to the hotel parking lot to be dedicated spaces for hotel registration – 15-minute parking. Currently these spaces are being used by local residents who park and leave their vehicles for very long periods of time (days). This change would greatly help out daily operations."

This item was discussed at the May 4, 2022 Parking and Traffic Commission meeting and it was approved to designate as a loading zone with a review in three (3) months.

### **FISCAL IMPACT**

Public Work's assessment of cost was approximately \$600 for two signs and \$400 for labor, amounting to \$1,000.
