**Subject:** Police report against Cliff Ogburn-Fw: signs placed in right-of-way

Chief Kole,

I am also in position to have Cliff Ogburn arrested for harassment. As you can see from the attached pictures taken a few hours ago, Southern Shores never took down the sign on the right of way near beach parking on Dogwood Trail. Southern Shores employees regularly pass this house and maybe the homeowner has surveillance to prove they do.

Cliff Ogburn singled me out in an entire town with people regularly putting real estate signs in the right of way for the purpose of harassing me without bothering other property owners. I asked how certain other signs were allowed, with a picture of the attached sign (assuming there was some type of permit to obtain) and Cliff Ogburn said he addressed the signs (which I assumed meant the signs were being removed). Cliff Ogburn then denied an application for me for "right of way" encroachment to place my real estate signs in the right of way.

I sincerely apologize for needing to file a harassment police report against Cliff Ogburn for his

discrimination and "selective prosecution" type of code enforcement, but town attorney Philip Hornthal told me to feel free to contact an attorney about my legal problems with Southern Shores, in a manner that substantiates legal entanglement, and prosecuting criminals working for Southern Shores is part of my strategy to get Southern Shores to comply with their own town code and not use illegally adopted codes to victimize and defraud property owners.

Southern Shores town code and ethics/conduct policy does not permit town employees to harass and defraud property owners with illegally adopted zoning codes or zoning codes not enforced on all Southern Shores property owners.

I will also be filing an official police report against Cliff Ogburn when I am contacted by Southern Shores police at 610 842 3905.

Mr. Mina – in reference to the two signs in the below picture in front of your property at 75 East Dogwood Trl, please be advised that Town Code Section 36-165 prohibits temporary signs in the right-of-way (except from 30 days before early voting begins and 10 days after an election). Please either remove these signs or have them moved back outside of the right-of-way. Otherwise, they may be subject to removal.
