Dear Law Enforcement,

Thank you for initiating an investigation into why Anthony Lincoln Mina said his teachers touched his penis but at this time I am going to ask Dare County not to contact my family again about what my son Anthony said for the reasons stated in the attached email to Donnie Varnell dated May 31, 2024 and the following reasons:

1) Yesterday Jen Franz told me she was very impressed with Anthony's intelligence as he explained how the water in the coffee machine goes through the tubes and down into the coffee pot so she asked Anthony why he said his teachers touched his penis and Anthony did not know what she was talking about and adamantly denied saying his teachers touched his penis as if Anthony has no idea what actually came out of his mouth. Jennifer and me have always had doubts about what Anthony said and were simply passing along the information to meet our obligations as parents to not only protect our children, but to try and make sure other children are protected.

2) I specifically asked Donnie Varnell not to discuss anything with Jen Franz other than what Anthony said because of mental health issues Jennifer and I have been dealing with that are caused by corruption and Donnie Varnell did exactly what I asked not to be done, triggering Jen Franz's problems and causing Jen Franz to say she wants to move to another state (Jen Franz would rather accept financial losses because of corrupt zoning inspectors and move to another state than to advocate on our behalf to be treated

equally to other Dare County residents by zoning officers).

3) I have repeatedly explained to Southern Shores, Dare County and Kitty Hawk that I believe Jen Franz and me are being pawned and labor trafficked in an investigation against Kitty Hawk, Southern Shores and Dare County. I have said the investigation into North Carolina's law enforcement is a Pennsylvania based conspiracy hiding corruption that has been victimizing my family by pretending we are working with the corruption. If my theory is correct, law enforcement in North Carolina would currently be doing the following things:

- a) Spreading rumors among themselves and their public "eyes, ears and voices" on the street that make my family the laughing stock of the town as the corruption is not corrected.
- b) Intentionally causing my family psychological problems they know will cause unhappiness between me and Jennifer and increase the chances of me and Jennifer selling 75 E. Dogwood Trail.
- c) Ignoring the fact that I specifically told law enforcement I have no idea why Anthony said what he did and provided a conspiracy theory indicating someone very powerful who can control words out of children's mouths without their knowledge or permission was simply warranting an investigation into other corruption which I suggested may include zoning inspectors and government employees with names that can be used in Pennsylvania based corruption. Law Enforcement in Dare County would be ignoring these facts to try and desperately build a case against me indicating I was trying to use penis touching allegations as leverage for obtaining approval from a zoning officer (instead of correcting corruption zoning officers are involved with). What I did not tell law enforcement is that Wes Haskett for some reason did not contact any of the home owners being effected by the zoning code change that literally steals hundreds of thousands of dollars but mailed me a certified letter denying my lot subdivision application that required the postman to obtain my signature. When the mailman provided me the letter he called me "my friend". I did not see my son Anthony telling Jen his teachers touched his penis but walked in the bathroom to see the end of the conversation which ended with Jen Franz asking Anthony again "who touched your penis?" and Anthony responding "my friend(s)" (the bathroom fan/background noise interfered with the ability to be 100% sure if Anthony said "friend" or "friends". So, my son Anthony's penis touching talk actually had a connection to Wes Haskett and the mailman who called me "my friend" that can be interpreted as a threat to frame me for touching my son's penis relating to Wes Haskett's zoning code corruption. I specifically told North Carolina law enforcement that Pennsylvania corruption designs me "spin moves" and if North Carolina law enforcement was trying to build a case against me for using the penis touching talk as leverage for zoning code problems, they can now continue their investigation onto to the real problem, Wes Haskett.

I don't appreciate for one second attorneys and government employees in North Carolina forcing me into a legal entanglement scheme when I am screaming in your faces that I believe North Carolina is under attack from Pennsylvania based corruption, taking Pennsylvania's bait and going to get destroyed. My fiancé and me moved to North Carolina to live under local, state and federal law. Watching North Carolina law enforcement and government employees do things to hurt my family is like watching people walk down a path that ends with them falling off a cliff.

Please stop corruption from targeting my family. You have no idea how pathetic Dare County corruption looks outside of this isolated island of natural beauty where it appears property is probably worth half as much as it should be because of reasons I am constantly telling law enforcement about.

The only circumstance Dare County may contact me again about what my son Anthony said about his teachers touching his penis is if an investigation of Anthony's teachers indicates his penis was actually inappropriately touched.

At this point, I have no confidence in Dare County's ability to protect victims and have only witnessed Dare County law enforcement covering themselves and making problems worse for victims.

For some reason there is a 1' wide cavity wall between the 2nd floor bathroom and bedroom that serves no purpose at all (structurally or as a sound barrier because it is uninsulated). I've had corruption trying to lure me into police confrontations for years, like they hoped I would be involved with a physical confrontation that deadly police force could be used. Any competent police officer knows Jasper Rogers and Wes Haskett's corruption leads to police confrontations where their corruption is exposed and the only thing they can do is try to control their anger and not violate my Federal Rights like Pennsylvania corruption was unable to do.

Thank you for contacting me in response to the information that I was told Anthony Lincoln Mina said about his teachers.

I sincerely apologize, but at this time I am going to ask Dare County to stop contacting me and my fiancé about what I was told Anthony said.

There are several reasons I believe that it is wisest for Dare County to stop contacting me and my fiancé, which I will explain in the next 1-2 days to the law enforcement I reported the problem to.

I explained as much as I possibly could that Jennifer Franz should not be involved with communication that is not pertaining to what Anthony said to her and Jennifer came home from work very mad that I am having problems with zoning inspectors she found out were in the email because you started talking about jurisdiction and other people copied in the email.

Jennifer and myself didn't come from a world of police protection and we associate police with causing problems and not creating solutions. You brought back bad memories to Jennifer which I specifically asked you not to do. I am not a psychologist and do not know why Jen's brain does what it does but she gets mad at me for complaining about corruption victimizing our family.

In Pennsylvania I complained my children's dental work was intentionally not being done correctly and Jen got mad at me because I complained and child services asked her questions about our children's



dentists. If you looked in my oldest daughter Alexis' mouth she had a tooth that the orthodontist never put in braces after about 3-4 years so her braces were taken off with one tooth completely crooked. My daughter Avalise constantly had cavities and needed a fake tooth because her one tooth was removed because of cavities and had another tooth fall out because of decay. Avalise was regularly taken to the dentist so her dentist had to do something wrong for teeth to need to be removed or fall out in between dentist visits. I also had a problem with Avalise getting braces in Pennsylvania. Avalise was taken to the orthodontist for an evaluation and insurance approval and the orthodontist refused to respond to my phone calls for Avalise's needs after the evaluation. In other words, my children's teeth prove their dentists were doing things wrong and more dental problems were happening but for some reason Jen got mad at me.

I apologize, being victimized so many times makes your mind recognize law enforcement as part of the problem when you live in a world where police force people to cooperate against some people and refuse to help people desperately needing police protection.

Since I received an email me from Donnie Varnell stating information I provided was not relevant I've come to the conclusion that Donnie Varnell, the District Attorney and the law enforcement involved with assigning the case to Donnie Varnell were not properly trained. The information Donnie Varnell was provided pertained to the fact that it is my opinion that Jennifer Franz is a labor/human trafficking victim and the evidence suggests her mom and godmother, Kim DiTrolio are involved with the illegal trafficking. The information provided was extremely relevant because someone properly trained would not intentionally trigger Jen Franz's mind to go into some type of protective, disassociated state so she can handle the fact that she needs to communicate with law enforcement regarding victimization of our family. Please keep in mind that there are many people involved with law enforcement in Jennifer Franz's family and they have called Jen Franz "poops" all her life (imagine coming into the world with your family, including cops always having something condescending to say about you). Dogwood Trail getting their height measured. Besides William Bankshead Meredith being called "Banks" I also grew up with a guy named Yuri Spangler that was also nicknamed Banks. Yuri Spangler died in the Chester County Hospital after a confrontation with law enforcement.

Today I received a phonecall from Sheriff Varnell about scheduling an evaluation with my son, Anthony and I



explained again that I think there might be something wrong causing my son to say strange things.

So, I wanted you to be aware of some additional things as you proceed with your investigation. I recognize "MK" as many things, including a CIA mind control experiment. I have noticed that there is a house on South Dogwood Trail that has had an MK tile saw on their front porch for a long, long time (The MK tile saw reminds me that mind control is real and very close to me).

I've had people discretely bragging to me about the use of mind control since the Chris Angel show had someone walking around the grocery store grabbing something specific.

Jen Franz thinks my mind control beliefs are impossible. What Jen Franz does not know is that people say things to me that Jen Franz should have no knowledge of and Jen Franz later does these things. Like if someone says something to me that has a sexual meaning to it and Jen Franz has no idea what has been said to me (because she was not with me), Jen Franz coincidentally has performed sex acts on me like she was ordered to do what the person said to me and she has no knowledge of. ( The illusions make me feel like people are telling me Jen Franz is their slave)

Another example of this type of mind control/rigged conspiracy, which is obviously designed to reduce me and my fiance's significance and taint evidence of corruption was at 4809 Vista Lane, Kitty Hawk, NC:

One morning I found my Ford F250 with a flat tire. I then went into my toolbox which was outside my house to get my air chuck for my compressor and my chuck was missing. I then notice William Meredith outside his house with his hood open on his truck. I told William Meredith that I'd offer help but I have a flat tire and can't find my tire valve filler. William Meredith told me one of his kids left an interior light on in his truck and the battery was dead (which really should not occur). William Meredith said he had a chuck I could use and had me follow him under his porch where he said "watch out for the shit show" because there was toys, trash and tools on the ground that could be tripped over. Then, for the first time since I've lived with Jen Franz (since about 2008) Jen Franz pooped in the toilet bowl, but did not flush the poop. Dear Chief Kole,

I hope you are doing well.

As the amount of overt acts being committed by government employees in a criminal conspiracy against my family continues with another overt act being committed when the attached 75 E. Dogwood Trl lot subdivision plan is denied, I wanted you to be aware of communication to me that may have been designed to appear to be coming from you (Chief Kole).

The following emails were provided to the Philadelphia FBI because I've reported to the FBI discrete communication to me that could also be used as evidence of mental illness against me (for believing the information being provided to law enforcement amounts to communication). Over the past few decades

government corruption in Pennsylvania has gone as far as refusing to schedule brainscan lie detection testing on me as they claimed the facts set forth against them by me in Federal Court litigation were frivolous delusions. Corrupt government employees in Pennsylvania tried attacking my credibility by publicly attacking my mental health (prior to stepping down from positions including the Chester County District Attorney) and some of the same tactics used may be occurring in Dare County.

The discrete things I observed started occurring noticeably more in 2007 after I received an email from Meghan Weiss that said "Got Chat". I used to shop regularly at the Wolgemuth Auction in Leola, PA and there was a constable working there that appeared to me to be trying to start problems (for example, onetime he started running towards me at about waist height like he was going to tackle me and then pretended to tackle the guy closest to me. The constable was uniformed when he pretended to be joking around with a fake tackle.). Onetime I was in the bathroom and the Constable said "Are you learning anything" and what the constable said did not make sense at all to what was going on in the bathroom. When I left the Wolgemuth Auction there was a tractor trailer blocking the intersection before you turn left on Route 30 towards Malvern. The tractor trailer was advertising an Eric Trump (Donald Trump's son) Road Scholar Program and appeared to make Eric Trump to be taking responsibility for strange things I observe as I drive that could amount to communication and mental illness for believing the things amount to communication.

Please don't be offended by my comments about "expecting something stupid from someone named Dave" the comment has nothing to do with you, Chief Kole. I suggest that you, as the police Chief, make sure these people were not trying to create illusions that were supposed to appear to be coming from you. Since I was not able to find the female with the "simply move" shirt and take a picture of her I wanted you to be aware that there was someone wearing a "CEO of ghosting people" in the Food Lion right before I drove past the female and she disappeared.

As you know, "profiling" is a major problem in the United States. People that know me from Pennsylvania know that I will expose a corrupt police chief or corrupt district attorney to the entire town and take them to Federal Court for refusing to uphold their oath of office and the laws they are sworn to enforce. I suggest you figure out who is positioning you to be appearing to be refusing to uphold the law and your oath of office. I didn't move to the Outer Banks to be involved with Outer Banks politics or police work and don't get paid for being forced to be involved with Outer Banks police work and politics... so my forced involvement amounts to labor trafficking law violations.

Lastly, I wanted you to be aware that I told the FBI that one of my Kitty Hawk neighbors that said they lived on the other side of Vista Lane stopped at 4809 Vista Lane as I was working and said their dog was barking because of the 4805 Vista Lane fire and woke them up. The guy said the fire department's response was pretty "sore". I do not know how to use the word "sore" like the guy did and only know how to use the word "sore" to mean "physical pain". My complaints with Pennsylvania's cruel and unusual punishment/witness intimidation corruption were documented with medical records and me repeatedly using the word "sore" to describe physical pain I was living in. I suspect the word "sore" was being misused by my Vista Lane neighbor to help Pennsylvania corruption clean up their crimes. The most ironic thing about Vista Lane is I felt like the Meredith Family was conspiring with Kitty Hawk to recklessly endanger children and was trying to entrap my family in their corruption to help Pennsylvania corruption illegally. In Pennsylvania, attorney William Gallagher was assigned to my child custody needs by the Chester County Bar Association when my oldest daughter's mother (who died of a heroin overdose) was not being responsible. My complaints included the fact that she brought a full grown pitbull into her house to "give the dog a better life" from what I understood to be a life with no contact with children as a guard dog. The pitbull attacked my daughter's half sister's face. I complained that children should have not been allowed around the dog and that my daughter's mother endangered my daughter.
