Dear North Carolina Law Enforcement,

I just wanted to tell you a little story that makes me think someone like Tracy Mann might be the target of psychological profilers trying to find someone to kill me. As I explained, Pennsylvania corruption appears to me to be involved with making North Carolina law enforcement look incredibly stupid and I wanted North Carolina law enforcement to look at their crimes against me and other property owners like this:

Some law enforcement in Pennsylvania know that I've started making a little kids book about Officer Friendly, the cop that introduces themselves to elementary school children. My book about Officer Friendly is on an elementary school level and teaches children the truth about street cops and how many street cops are nothing more than an organized crime family/political lynch mob only protecting and

My book starts by showing Officer Friendly uniformed, introducing themselves to children and telling children not to use drugs and then shows Officer Friendly progress into different people, and eventually the devil by baiting people with things like drugs (my book describes the way law enforcement does these things so the moral of the story is "lead me not into temptation" and the cop is doing the devil's work but refusing to do police work (my book is on a level that religious organizations will respect and acknowledge as a real life government problem where the police/government suffer from a moral bankruptcy because they are too busy engaged in a vulgar display of power to comply and enforce their own laws).

Here in Southern Shores I have proven Wes Haskett is part of a real estate scam withholding material information from me about 75 E. Dogwood Trail as Outer Banks Realty Group negotiated an additional \$75,000 from me, I have proven Wes Haskett falsified information to Chief Kole and I have proven Wes Haskett is continuing to commit crimes like tax fraud against many Southern Shores property owners when the only thing Wes Haskett is in position to do is correct Southern Shores wrong-doing (not spend Southern Shores money on attorneys slandering me and doing anything but correcting the wrong doing that Southern Shores property owners are being over taxed on because of Wes Haskett's fraudulently adopted zoning codes).

In Kitty Hawk the police and Jasper Rogers refused to keep children safe from an extremely dangerous Hummer that Kitty Hawk zoning code officers should have immediately towed. The entire Vista Lane cul-de-sac looked like an illegal junkyard not permitted by Kitty Hawk zoning code with violations all over the place that substantiated "danger" to children and Kitty Hawk zoning inspector Jasper Rogers stole from the town in a conspiracy with the zoning code violators by refusing to fine them as required (some of these violators also rejected my offer to pay the costs of correcting their zoning violations, as information provided to Kitty Hawk proved). Subject: Murder Suicide Mission Orchestrated From Pennsylvania

Dear North Carolina Law Enforcement,

I hope you are doing well.

I am writing you because I believe that in addition to North Carolina law enforcement being suckered into Pennsylvania corruption schemes where North Carolina's government will lose power to Pennsylvania based interests, I also believe North Carolina law enforcement is a target of a murder suicide mission where I am supposed to be the murder victim to a corrupt North Carolina employee (like people destroying me want Jen Franz to be receiving a wrongful death settlement... like they think they own Jen Franz and can steal/embezzle her money from her).

As you may be reluctant to admit, I don't commit crimes and if you try slithering around to find a way to claim I do commit crimes your only hole is "Tony Mina drives his Ford F250 with the flow of traffic, which sometimes means he is not paying attention to his exact speed and has had police vehicles pass him without their lights flashing". (Trying to interfere with my business/financial needs, coerce me and entrap me in financial schemes only results with internal affairs ripping apart Dare County's op against me and my business into another case against law enforcement). So, in addition to North Carolina corruption targeting me adding up to things like witness tampering, North Carolina law enforcement is clearly on a path that violates criminal negligence laws, causes me psychological problems where the post traumatic stress disorder North Carolina is intentionally triggering will result with North Carolina law enforcement being liable for the things I do and lastly, North Carolina's criminal negligence is probably expected to lead to my death, by a government employee, like a cop I am forced to expose for being corrupt and allowing people to victimize my family and other property owners.

You are probably thinking "wow" death by a cop, haha so I just wanted you to be aware that about 21 years ago when I was suffering from 2 herniated discs, 5 bulging discs and 1 fractured disc in my back I wasn't being prescribed medicine competent doctors should have prescribed, like anti-inflammatory medicine and pain relief injections into my spine (I did not know these things existed as I was treated by doctors Paul DeBacco, Virginia Keeler and Andrew Cherry) and I relapsed into a PCP (angel dust) addiction with lots of alcohol that helped deal with the back pain. When I was self medicating I became aware (through anonymous information) that corruption uses PCP to fill people with suicidal aggression and I had no problem at all getting PCP. So I stopped using drugs more than 20 years ago and one of the guys I used drugs with, Yuri Spangler, died from a police altercation when on PCP and another guy I used drugs with, John Crabb took all his clothes off and jumped on top of a police car screaming "fuck the police". So...my death by cop theory isn't exactly far fetched. My name coded moluscum penis crime family (involving healthcare workers) theory leading back to Peirce Middle School also isn't exactly far fetched. I also became friends with a guy name Tom Barrett and Tom Barrett had his penis pierced. The strange thing about Tom Barrett's penis being pierced is the hole in his penis was supposedly from a spring in a jumper ripping a hole in his penis when he was a kid. Tom Barrett supposedly died after checking his self into the Chester County Hospital (the hospital helping police hide injuries I suffered from by the police during an arrest when I was 16 years old).

Competent law enforcement in North Carolina would know that their corruption attacking me is triggering my PTSD because these attacks from corruption are a continuing pattern since I was a juvenile and the police and hospital were trying to hide the injuries the police caused to me.

For example, when I was a juvenile my mom said "If you don't like my rules, go live somewhere else" and I moved out of my parent's house, knowing that the approximately \$500 a week I could make working was more than enough to rent a room in the college town of West Chester that I lived in. Then Chester County Hospital Board member, Judge Paula Ott put a bench warrant out for me for violating probation when I was not on probation, so I was unable to work a job with a bench warrant and didn't have a house to live in until after I got caught with my bench warrant.

Then in 2021 corruption went nuts again trying to frame me and make me lose my home improvement business which was then servicing about 115 clients on a regular basis. Their plan failed and I obtained about 30 more regular spring, summer, fall clients and 90 winter clients for snow removal services.

Then in November of 2022 I suffered from an injury of 2 herniated discs, 5 bulging discs and a fractured disc in my back

being neglected and by 2023 half of the clients I had found a new property maintenance company and in 2024 the business had to be sold (Keep in mind that the police control the word on the street and slandering me to reduce the public's perception of me is how they hide corruption, so I wasn't known as the guy being neglected by doctors, I was known as the guy with a drug problem).

After years of getting my life together starting from nothing but a rented room with Makeda Marley I was renting a house for me and my daughter, all by myself. I painted the entire interior of the house and carpeted several rooms, making the house much nicer. Then in November 2007 I had another back injury (keep in mind that when I talk about back injuries I'm talking about a pinched nerve in my back that hurts so much that in the mornings I am sometimes crawling around on the floor and I would get to sleep by drinking lots of alcohol), but this back injury came with another storm... the police were in the middle of trying to frame me again (I caught the police and my lawyer Dawson R Muth framing me which is another reason I am hated so much) and my house was vandalized so the heater did not circulate water through the radiant heat (it only burnt oil), something happened to the well that made it produce brown water, my landlord lied and said his insurance company said I couldn't use the wood stove his friend Gary Cleveland installed in my house and the heater on my water bed broke. So as I was drinking myself to sleep I also was waking up in a house so cold you could see your own breathe (I stayed at my parent's house when my daughter was staying with me) and my landlord would not fix the problems.

In 2010 me and my fiancé were unable to purchase at least one home we liked offering asking price and purchased 100 Bridge Street where a home inspection indicated the house needed a new roof. It turned out that installing a new roof was nearly impossible because the walls weren't properly built so I needed to rebuild the house from the foundation up after I coincidentally suffered from another back injury a few days before the work at 100 Bridge Street had to start. The work required would have bankrupted someone that wasn't capable of working more than 70 hours a week making home improvements.

As you can see from my Federal Law suits, Chester County never stopped attacking me with corruption and by 2014 I was regularly suing Chester County as I was suffering from yet another back injury that had me crawling around on the floor in the morning with Chester County's government refusing to reschedule a workers compensation claim I made that was postponed because the guy I was working for walked out of the courtroom because he wouldn't answer my cross examination question. In 2014 I was finally provided anti-inflammatory medication for my back injuries and the pinched nerve pain that has caused me crazy amounts of pain for weeks and months at a time before has now become easier to deal with (I for some reason was given healthcare from Dr. Jennifer Keah instead of the Main Line Doctors I had been seeing for decades).

In 2017 DA Tom Hogan's corruption wouldn't stop attacking me (they create illusions so their attack against me appears to be evidence for me to use to infiltrate places like Federal Courts, like I am working with them, when I absolutely am not and my Federal tax returns prove I am not getting paid by Chester County corruption or any of their ops)... and I was forced to expose DA Tom Hogan and he stepped down as District Attorney (to spend more time with his family). Pennsylvania corruption was forced to regroup, I built another addition on the house me and my fiancé bought for \$110K and sold the house for \$820K and I moved to the Outer Banks to find a safe place for my family.

Little did I know corruption from Dare County would obnoxiously make sure I viewed their corruption as Pennsylvania corruption intimidating me, again. Southern Shores town council has people all named similarly to the corruption from 1996 that Paula Ott and Robert Holland were 2 of the main corrupt government employees, Matt is the name of a guy called "horse" that I met in 1996 when court records indicate I was waiting for an inpatient bed at a rehab but sent to Mark's intensive rehab and had lots of females that wanted to get in bed with me (the name Neil has an interesting meaning to me, because when I bought 100 Bridge Street I asked Bill Wilfong, the building inspector how I could build additions on my "non-conforming" house and he said I could build up on the existing house, but could not build any more non conforming structures. So I built up as Bill Wilfong said I could and there was a zoning inspector named Neil that also approved my building plans. As I was building, my neighbor Peter DeLaurier asked me for some dirt I excavated doing foundation work and I allowed Peter to take some dirt and another day Peter asked me if I had enough dirt to build what I was building. Peter worked with DA Tom Hogan at the People's Light and Theater and what Peter was saying had an interpretation to mean that I was building my house the way I was because I had "dirt" (negative information/blackmail) on someone, when the truth is I was building my house the way I was because Bill Wilfong helped me make decisions about building additions. After I built my 3 story addition I had a guy named Jeff come to my house to purchase windows I was selling (he said he was building a barn) and Jeff was complaining he did not know I could build a house as big as mine on the lot when he looked at the house in 2010. So, Kitty Hawk and Southern Shores zoning officers creating problems with me may actually be the 4th time I've had a zoning officer causing problems (Tiffany Loomis replaced Neal in Malvern Borough, told me I couldn't work on something I already started then came to my house saying things like "there is a fire inspector named Tony Mina, are you a fire inspector"...and someone definitely needs to check on Kitty Hawk's fire inspector, who won't provide me Mike and Lea Meredith's account of their house fire which I

need to make claims for damages through my insurance company and/or in Federal Court). The bottom line with the zoning inspector drama is government corruption is so pathetic and desperate they are now attacking me with zoning inspectors and trying to label me a nuisance because they are defrauding property owners and endangering children.

Anyway, sorry to ramble on. I wanted to specify:

A) The continuing pattern of corruption attacking me that is trying to bankrupt me, illegally, with things like corrupt zoning inspectors (Wes Haskett and Jasper Rogers) forcing me into legal entanglement schemes and doing these things with knowledge they are violating involuntary servitude/slavery laws.

B) The intentional psychological suffering caused by the corruption can trigger my PTSD so things I do are things corruption is liable for (For example, if corrupt law enforcement neglects to correct wrong doing and the wrong-doing triggers a PTSD episode that results with someone being killed, the corrupt law enforcement is liable). I do what I got to do to protect my family and if Southern Shores and Kitty Hawk corruption wants to make my life more difficult because I've caught their corrupt zoning inspectors, just keep in mind you are triggering PTSD that brings me to a world of being attacked non-stop by corruption and I'm crawling around on the floor in excruciating pain with a corrupt government that won't even hear my workers compensation claim they were supposed to reschedule. Don't think for one single second that because I'm riding my bike around for exercise and smiling with my family that North Carolina corruption isn't one wrong move away from one of their worst nightmares. I know people like inflicting pain on me and want me dead so North Carolina's corruption thinking they got time to do something other than correct the wrong-doing is dead wrong.

C) I wanted North Carolina corruption to be aware that in addition to witness tampering, involuntary servitude, criminal negligence and the long list of other crimes being committed against me, you are also going to be liable for attempts to hide Pennsylvania's corruption. For example, Jen Franz regularly said to me "your humming" and "stop humming" because my PTSD would bring me to a world where I would be thinking about getting attacked by corruption and for some reason I start humming as my mind is disassociated from where I am at. William Meredith's use of hummers doesn't change the fact that I repeatedly told Chester County corruption to keep me out of their lies the entire time I wasn't mentally and physically well enough to be forced to be in the middle of corruption. I never once agreed to be a part of William Meredith's Hummer corruption because Jen Franz said things to me sounding like "You are Hum-in". After Mike Meredith's house burnt down a couple introduced themselves to me as neighbors of mine on the other side of Vista Lane. The couple was telling me their dog woke them up barking when Mike Meredith's house was on fire and the fire fighters response was "sore". I don't know how to use the word sore to mean anything other than physical pain. Dear Norwood Blanchard,

I am writing you because on August 30, 2024 I received an email from Norwood Blanchard stating my complaint against Southern Shores and Kitty Hawk was meritless misconduct and I responded with a request to schedule lie detection on me and your clients. Why are you not responding to my request to schedule lie detection after slandering me?
