Hello Law Enforcement (please forward this email to Chief Kole, Mr. Hornthal),

I have more evidence of the criminal conspiracy I complained about in Pennsylvania that has followed me to North Carolina. I've got too much to do today to organize the evidence in the email so law enforcement knows exactly where the evidence is part of the puzzle.

The additional evidence is:

-Angela DiRocco's nickname was Ange. I'm not sure who bought the Corl's house on Locksley Drive in West Chester, PA but if there name was Wang you should be aware that I am 100% sure that wang was a word used for penis by me when I was a kid. I was once led to believe that the stories people told about Glen Corl hot wiring a bull dozer were talking about Christina DiRocco.

-Jen Franz worked with another 5th grade teacher at West Chester Sarah Starkweather Elementary School named Erica. Onetime Jen Franz told me Erica was coming to 100 Bridge Street with her kids because she wanted to "sit by the pool". Jen wasn't very happy that her co-worker wanted to come to our house and I wanted law enforcement to be aware I believe Jen Franz's mom, Donna bought the kiddie pool with about a 48" diameter that Erica wanted to "sit by". (Please keep in mind when someone like Jen Franz's Aunt Kim says "I'm giving you grandma's chair" that Kim Ditrollo literally brought a chair that your butt sits on and called the chair "grandma's chair").

-I've explained about a "casey" named coded conspiracy and how "Kasey Rabar" is pronounced "Casey Ray-bar", and Kasey Rabar represented the buyers of my last house (the Ratcliffe and Nelson family). **Cliff Ogburn is the corrupt Southern Shores town manager and the reason I signed a contract provided to me from Terminex's Brad Fisher with Terminex's employee Jason Viar is because of an obvious rat infestation problem in the attic of 75 E Dogwood Trail (there was literally shovel fulls of rat poop in my attic to clean when I bought the house).** Now Jason Portnoy is assigned to my insurance claim of fraud against Wes Haskett and Southern Shores (by my insurance company) and Jay Wheless is the Southern Shores Planning Board attorney I caught fraudulently misrepresenting town code 36-414(b) with Wes Haskett's attorney Lauren Womble at my Variance hearing on October 21, 2024 (which was recorded and added to the Southern Shores website). I did not sign a contract with Jason Viar so Jason Portnoy and Jay Wheless could vie over my \$75,000 fraud claim against Wes Haskett. I signed a contract with Jason Viar because he was supposed to prevent rat infestation at 75 E Dogwood Trail but never showed up to do the job. Since I've explained that the Kitty Hawk Home Depot has an employee named Ray that often works in the Garden Center that looks a lot like Jen Franz's dad, Chris, to me, I suggest law enforcement investigate William Joshua Kenner's wife, Chrissy Kenner for a Facebook post saying she works at the Home Depot Garden center and has a problem buying plants (in case there is code that suggests "Ray" at the Kitty Hawk Home Depot is really Jen Franz's dad, Chris). People discretely tell me things about Jen Franz's family and I've felt like Jen Franz's dad Chris has people making him appear to me to be involved with the conspiracy, when he may not be involved like I am led to believe.

-I suggest law enforcement investigate if I was sent to the Chester County "Pre-Release" Center and had a roommate named Cliff in 2001 since I was provided a copy of my criminal record without my 40 days in jail in 2001 being identified on my criminal record...and Cliff Ogburn is not allowing me to advertise a real estate opportunity at my house selling a co-ownership with a real estate sign near my mailbox as realtors advertise 365 days a year in Southern Shores with signs near then street. **Cliff Ogburn's interference with my work because I caught Southern Shores changing zoning codes without notifying effected property owners violates state and federal witness intimidation laws.**

-Pennsylvania healthcare's system assigned Maureen Vita to be my daughter Alexis' therapist when I wanted her to talk to a psychologist. I now live at 75 E Dogwood Trail and "Jeff" bought 73 E Dogwood Trail. Jeff hired Ben Vorondran to help renovate 73 Dogwood Trail. Ben Vorondran often wears a brown shirt and is a retired Marine. The conspiracy I complain about uses music and Rihanna and Eminem's song "Friends with the monster" sings about Jeff Vorondran. More than 20 years ago I was led to believe (with communication that law enforcement would have probably used as evidence of paranoia) that people were getting Ben Brown to kill me. Something I supposedly said to Eric Frindt would have been used to try and manipulate Ben Brown to kill me. Eric Frindt was coincidentally scheduled at the Chester County Probation Office on March 19, 2008 when Dawson R. Muth took me there after I was sentenced to probation (so me and Eric Frindt talked in the waiting room). When I believed I was being threatened that Ben Brown was going to be used to kill me I believed the information was coming from cops, I suggest law enforcement investigate the coincidence that Eric Frindt was scheduled at the probation office on March 19, 2008. The conspiracy I complain about likes using thought control and Eric Frindt being in the probation office after I wore 2 whistles around my neck at sentencing was part of a threat to have me killed for complaining about corruption attacking me. I'm not sure if the name Maureen Vita means "Marine Vy-T-A" but Jen Franz asked me to get benadryl and then I observed Ben Vorondran walking towards me from 73 E Dogwood Trail with a drill in his hand (the conspiracy I complain about uses communication from people to make them appear to be involved with schemes they really are not involved with). Oneday Ben Vorondran said "now you are going to kill me" as he said he could not remember my name (me and Ben talked many times and he's called me "Kevin" before because he said he could not remember my name). I suggest law enforcement investigate Ben Vorondran being used to clean up Pennsylvania corruption's threats to have me killed.

-Jen Franz had a business card in her purse with Icon Solutions employee's name "Jeff Dickinson" on the card. Jen Franz has no idea how the business card got in her purse. Dick White is an old owner of my house that is very well known in the community and the bridge over the canal I live on is named after.

-Jen Franz's mom Donna lives on Biforde road in West Chester, PA. There also is a cumbrian road in her neighborhood. When I complain about Brian and Colleen Lloyd appearing to me to be a part of Chester County Hospital corruption please keep in mind that Debbie Schwartz took me to MedCenter 100's Urgent Care Center because I had severe back pain from a pinched nerve/herniation. I was taken to the doctor and Tara Pumala came into the room to talk to me. Then the doctor came in the room and told me I needed to wait 2 days to get pain relief medicine injected into my back. I was in lots pain and me and Debbie then went to the bar a few doors down where I got back to my self medicating with alcohol and drank 9 beers. I was in so much pain when I asked for my 10th beer the waitress said "you just drank 9 beers I can't believe you are still standing" and I said something like "my back hurts too much to sit down" and I bought a 6 pack to go. I wasn't in the doctors office because I had a little pain, I was obviously in need of immediate care but was told I needed "to wait 2 days". Please also keep in mind that Donna Franz ordered me and Jen Franz 4 chairs. The 4 chairs Donna Franz ordered are in our screened porch and called "Adirondack chairs". I'm not sure if cops and politicians use numbers like "2" and "4" in their schemes but I am sure that I had to talk to Jim Forsythe before (I believe he was the Chester County director of elections) because of complaints I had about corruption. Jim Munroe sold me 75 E Dogwood Trail and the name coded communication would indicate something like Chester County corruption is sitting 4 chairs in Southern Shores by using me as their labor/human trafficked pawn. Wes Haskett has put me in position where I feel like I could expose Southern Shores town council, planning board and police chief and have the town hall packed with angry property owners wanting all of them ousted. I did not move to Southern Shores to sit and split boards and police departments. I moved to Southern Shores to work as a home improvement provider and give my kids the life I dreamed of as a kid, which was as much time at the beach as possible.

-When I was building a 3 story addition on 100 Bridge Street I ordered the materials from the Frazer, PA Home Depot. Home Depot delivered the materials but did not deliver insulation I needed. I contacted Home Depot and was told that they can give me "4 batts". 4 batts of insulation out of my ordered insulation sounds like a ridiculous thing to offer someone who ordered such a larger quantity of insulation. The coincidence is Jen Franz moved out of the house we owned together in 2017 for a few weeks. When Jen Franz moved out she bought a vibrator. When Jen Franz moved back to 100 Bridge Street she told me about the vibrator and said the batteries died when I said I wanted to use the vibrator on her and the vibrator used 4 batteries. I'll let law enforcement figure out why Home Depot offered me "4 batts".

-Onetime my neighbor at 100 Bridge Street Tom Teti hired me to work at his ex-wife's house Jenny Teti. Jenny Teti paid me with a check and I brought the check to the Frazer, PA Wells Fargo to deposit the check. The teller, who I believe was named "Sondra" said something to me like "be careful, Jenny paid you with credit". I clarified that the teller was saying the check Jenny Teti paid me with was from a credit account. I suggest law enforcement make sure someone named Jenny (Jen Franz's dad and brother have called her Jenny before) isn't labor trafficking me and trying to coerce me to sound like I am being paid with credit (Jen Franz and me sign loans together). Since Tom Teti worked with DA Tom Hogan I would imagine Jen Franz being the framed fall guy of a human/labor trafficking scheme designed by Chester County District Attorney's Office to hide their corruption.

-Since Wes Haskett is a major part of Southern Shores' corruption I wanted you to be aware that the last time I talked to Steve Washington we were in Mike Dempsey's 15 North Bar and Steve Washington said he worked for West Chester Insulation and was talking about Lewis Wesley.

-I wanted to make sure law enforcement was aware that I went to West Chester East Highschool for my 11th grade year and Angela DiRocco and Heather Gittings also switched schools to East High School. I was told that Heather Gittings (horses say "giddy-up") was at East High School because she was having an affair with Henderson Highschool's "Mr. Redmond". I did not have Mr. Redmond as a teacher but had Ms. Redding as a teacher. The last time I saw Heather Gittings was when she was a Philadelphia Eagles cheerleader. I had seats near the field and was wondering why there was a cheerleader looking like she was waving to me and I realized it was because the cheerleader was Heather Gittings and she was saying hi to me. In Henderson Highschool me and Jay Auger both used to joke around about how we liked Heather Pardue, a female that sat in front of us in Mr. Hay's health class (hay is for horses is a term that I've unusually heard). Onetime Mr. Hay singled me out in front of the entire class about the essay I wrote on a litter clean up volunteering thing I did. Heather Pardue was the kind of female impressed with things like academic excellence and that day I was probably looking at Jay Auger thinking something like "who's she smiling at today, Jay?". I noticed on Facebook that Heather Pardue is now Heather Thompson and my realtor at 4809 Vista Lane, Kitty Hawk, NC is on Facebook as Heather Thompson Vandermyde. I think the fact that Vista Lane has a corrupt zoning inspector allowing the Meredith family owned properties to have litter and junk vehicles/equipment all over the place is a crazy coincidence since Heather Vandermyde called the zoning inspector herself to figure out when the junk vehicles were being removed (I felt like the scheme was written by Chester County corruption that likes replaying things). Please keep this in mind when observing red light schemes.

Hello Law Enforcement (Mr. Hornthal, please forward this email to Police Chief Kole and Town Council),

I have some additional information evidence of sexual coercion. Please keep in mind that Pennsylvania/Chester County corruption illegally hides their crimes against me, lied in Federal Court (I caught Chester County lying and using \$50,000 of tax payers money to file false sworn statements known to be false when filing them and known to be false when DA Tom Hogan initiated his DA Tom Hogan Facebook page witness intimidation and ridicule of me for exposing his corruption). So, North Carolina is going to need the FBI to help prosecute the continuing pattern of corruption that has followed me from Pennsylvania.

Some facts that I believe are relevant are:

-I filed a private criminal complaint against the Chester County Daily Local News for claiming to their customers to be selling a "complete news package on multiple platforms" but in reality the Chester County Daily Local News was refusing to publish paid advertisements that had facts about Chester County government corruption (information I had documented in court transcripts, Orders and emails from Chester County's email system.) The Chester County District Attorney refuses to decide my Private Criminal Complaint pursuant to the Pennsylvania Rules of Procedure. I once advertised "We The People LLC" in the Chester County Daily Local News selling clothing. Despite the front page advertising supposedly reaching thousands and thousands of customers, "We The People LLC" only received one order for clothing from someone named "Chris Fagerly". I'll let law enforcement figure out if there is a name coded sexual conspiracy consistent with what I have been telling law enforcement. I've been telling law enforcement how corruption and lie injectors use music to make schemes and when I was involuntary committed to the Horsham Clinic about 21 years ago for things like "paranoia of corrupt cops" that supposedly didn't exist I was given an assignment where you needed to draw a door (like a greeting card) and when you opened the door show something inside the "door". I drew a picture of a guy with dreadlocks fishing as he was leaning on a barrell that said "coconut # 1" and the guy caught another guy with a stamp collection. The guy with the dreadlocks said "What the blood clot". I drew the picture because I once found a stamp collection at 47 Carol Lane and brought the collection with me to a meeting with attorney Fran Miller and Fran Miller really wanted me to leave the stamp collection with him and said he'd sell the collection for me (I'm not sure if Fran Miller was hoping to find a way to get me in trouble with the stamp collection). I'll let law enforcement figure out if people like Mike Meredith and Brian Lloyd fit into the song as "faggot soundmen" or if Cliff Ogburn fits into the song.

-I wanted law enforcement to be aware that when I was a juvenile in the Delaware County Detention Center I developed a rash on and around my penis that the doctor at the detention center called "moluscum". The rash disappeared and I don't have moluscum. I believe someone at the detention center did something to my underwear or penis when I was sleeping so they could talk about my penis "contracting moluscum" as "bar code" (my penis did not itch at all, like poison ivy would). Jack Whelan's Delaware County District Attorney's Office concluded (I filed a private criminal complaint) that the reason the Delaware County Juvenile Detention Center won't give me a copy of my juvenile records is because they are in Chester County government's possession. Chester County's government refused to provide me a copy of my juvenile records that included my records from the Delaware County Juvenile Detention Center. I filed a Federal Law suit against Chester County in 2013 and Judge Mitchell Goldberg sent U.S. Marshalls to my house to ask me questions about my case (without the defendants being at my house). I told the U.S. Marshall's about my penis and asked them if they wanted to see my penis (to prove I don't have moluscum) and they did not want to see my penis. I filed a private criminal complaint against Federal Judge Mitchell Goldberg with the Philadelphia District Attorney's Office for refusing to report mandated suspected sex abuse (I believe I am providing the exact information right now, the private criminal complaint is in storage right now). The Philadelphia District Attorneys Office had a woman named something like "Schanda L Hassel" (I believe that is her exact name) communicating with me. Schanda's communication started with a phonecall where she began laughing and calling me "Mr. Weina" (like she was talking about a penis like little kids talk). Schanda L. Hassell's name has some coded meanings law enforcement should investigate. A hassell is something that is difficult or bothersome when talking to someone like Gary Cleveland (U.S. Marshall's hassell me at the Philadelphia Federal Court). The conspiracy uses "sh" code (Jen Franz's family had a picture taken of them in front of a Roy Woods billboard in New

York City where Roy Woods was giving a "sh" signal. I believe Jen posted the picture on Facebook and her family had coffee cups made with their pictures. I'll let law enforcement figure out whether Jen Franz communicates using a "sh" code or just has people coercing her and using codes with her that she does not know the meaning of). L means lesbian in their code and since Andy Ward is part of the conspiracy in Southern Shores against me, please note that Andy's name is in the name "Schanda". (Now Andy Ward's corruption is tied to moluscum penis corruption being hidden by Pennsylvania corruption). Schanda L. Hassell dismissed my complaint against Judge Goldberg and Pennsylvania corruption would do something like design a fake scheme with Andy Ward to pretend my criminal complaint against Judge Goldberg was part of an agreement for a scheme with Andy Ward, which it was not.

-I wanted law enforcement to be aware that ECU health assigned Dr. Eadie to be my primary doctor. Prior to moving to North Carolina when Marie Gordon was my realtor I coincidentally noticed "gordon eadie" landscaping trucks driving near me. Dr. Eadie used to wear a U.S. Army lanyard because her son is "in the army". Dr. Eadie was replaced with Dr. Tom Ferguson. If I was law enforcement I'd investigate why Dr. Tom Ferguson was assigned to replace Dr. Eadie. Tom Barrett and Jay Ferguson (my old 47 Carol Lane roommates) both went to the Chester County Hospital with health problems somewhere around age 32 and they both died. Dr. Tom Ferguson replaced Dr. Eadie when William Meredith ("Banks") was my Vista Lane neighbor. Yuri Spangler ("Banks") also went into the Chester County hospital in his 30's and died. The Chester County Hospital sent me an email from Collee Leyden and Colleen was my Vista Lane neighbor and her kids names are William and Wiley, like the Chester County Hospital Board member, William Wiley. It is my position that corruption, including healthcare workers use intimidation tactics to remind me corruption can frame and/or kill anyone in the United States, including JFK. In the Outer Banks, NC I feel Chester County corruption along with Chester County Hospital corruption trying to intimidate me.

-In the Outer Banks, NC they appear to be playing games with red and green lights. I wanted law enforcement to be aware that the red/green light meanings I observed started with my neighbor at 100 Bridge Street, Malvern, PA 19355, Peter Delaurer having a red light on his bathroom window sill every night. One night he changed to a green bulb and when I observed the lights being changed from green to red I also observed information that said "red means go". My neighbor's on Bridge Street, Tom Teti and Peter Delaurer both work at People's Light and Theatre, where the old owner of 100 Bridge Street worked and DA Tom Hogan worked. As you can see from Peter Delaurer's communication to me when I'm living in the Outer Banks, Peter Delaurer communicates so people can assume I still own 100 Bridge Street, which I do not (Chris Joiner and Julie Avertine bought 100 Bridge Street on September 19, 2022). Peter Delaurer's girlfriend's name is Lesley. The conspiracy tries to teach me codes so I do things they want me to do so they can pretend I am working with them, when I am not (I tell them repeatedly to keep me out of their lies). When Joe Jackson, the old Peirce Middle School Principal referenced in the bottom of this email was talking to me at the Exton, PA Aldi store he told me he works at Devereau ("I work at Devereau"). After I talked to Joe Jackson I observed Tom Devereau (Molly's brother I went to school with) walking on route 100. Another significant thing about me talking to Joe Jackson at the Aldi store is when I lived at 47 Carol Lane I believed people were telling me something about my social security number being used in some type of code. I also was led to believe that "a belt" is code for mind control. The Exton Aldi store is where I realized Sunbelt rentals has the last 4 digits of my social security number in their phone number (9328) because they had a piece of equipment at their store.

Hello Law Enforcement (please provide this email to Chief Kole, Mr. Hornthal),

I wanted to make sure law enforcement was aware of these facts so they understand what Pennsylvania corruption is doing in North Carolina as people like Wes Haskett and Jasper Rogers intentionally cause me and my family financial and emotional damages (there are many random facts that are unorganized and scattered because I am in the middle of getting \$75,000 stolen from me because of Wes Haskett's fraud, which is more consistent with a sexual coercion conspiracy than town code...so I don't have time to organize information for law enforcement when I need to work and sell my house before Wes Haskett causes me more financial problems):

When I was 16 years old I was assaulted by law enforcement in Chester County, PA (the cops names I believed were most responsible were Pam and Steve...now Steve and Pam Diehl, pronounced "Deal" live in Southern Shores and were originally from somewhere in Pennsylvania-I can't remember the town). The police took me to the Chester County Hospital emergency room and then to the Delaware County Juvenile Detention Center where I was held until after my injuries healed (I had cuts and bruises all over my face). At the time I was taken to the detention center I already had an arrest for possession of PCP. PCP has a streetname called "sherm(s)". Casey Loftus's nickname is "sherm". Corruption uses names to communicate, including double codes. Casey Johnson is someone that coincidentally would be held in the detention center when I was there and was scheduled on March 19, 2008 in the Chester County Probation Department when I was taken there by Dawson Muth.

It is my position that corruption coerces me into things that are the equivalent to "suicide missions" and situations that are intended to cause me so much suffering, including physical pain that my PCP addiction I had at 16 years old would be

triggered. The name Casey would be used to communicate schemes to drive me into a crazy PCP addiction (I grew up with Yuri Spangler, who died after an altercation with police when high on PCP and John Crabb who did things high on PCP like took his clothes off, stood on top of a police car and screamed "fuck the police". Yuri Spangler told me his dad "skip" was a research chemist and tested PCP on lab rats. I believe Yuri Spangler's dad, Taylor ("skip") drove a car with a license plate that had "Casey" abbreviated and so did my fiance's mom, Donna Franz ("Gigi") (I believe state license plates are sometimes coded). I stopped resorting to PCP as a way to cope with pain 21 years ago. After I saw Casey Johnson in 2008 everything in my life went wrong from work, to child custody to my home being vandalized and the landlord refusing to fix the problems. Instead of using PCP in 2008 I did something I never did before...I also quit drinking alcohol so I could focus on destroying corruption preying on me and my family.

The Delaware County Juvenile Detention Center hired Suzanne McDonough to represent them when I sued them. "Mick" is a name for Mike because of Mike Palloni and Donough is pronounced "Donna". (You might want to investigate people named Mike and Donna working together). Donna Franz and Kim DiTrollo took Jen Franz to Paris, France. Jen Franz came back to the United States and needed to be hospitalized for a few days because of "food poisoning". Jen Franz gets handed clipboards from healthcare workers and I have witnessed her not reading a single word and signing them. Jen Franz would not even know if she consented to having chips, cochlear implants and all other kinds of crazy medical procedures spies get. Paris Webb is an employee at the Delaware County Detention Center that Jen Franz could have been coerced to sound like she was talking about. Donna Franz's boyfriend Tom McLean worked at the Delaware County Juvenile Detention Center. Josh McDonough is someone I went to highschool with. The last times I saw Josh McDonough was at the Exton Square Mall Food Court and Wholesale Service Incorporated (he was driving a fork lift) as I was purchasing lumber for my 100 Bridge Street rooftop deck.

I believe Pennsylvania corruption is trying to clean their "casey" code and give their code a new meaning which involves Laura Polini. Jen Franz was assigned Laura Casey to be her gynecologist here in the Outer Banks. Kasey Rabar (pronounced Ray-bar) was the Ratcliff and Nelson's buyers agent when buying 4809 Vista Lane. The Kitty Hawk Home Depot has an employee named Ray that often works in the garden center. Ray looks like Jen Franz's dad, Chris. Casey Varnell obviously is an incompetent corrupt attorney representing Kitty Hawk (probably because his name). Mike Casey was Linda Lauby's attorney who works with Nancy Dawson.

When I talk about doctors/healthcare workers please keep in mind that you talk about "co-pays" with healthcare workers. Me and Jen Franz had Coe Insurance (home owners insurance) on 100 Bridge Street and they paid about \$50,000 for a water leak that I believe was probably vandalism designed to coerce me and jen franz to sound like we were talking about something we were not.

Please also keep in mind that I was unable to get a survey for 75 E Dogwood Trail done properly for a reasonable price other than Douglas Styons (I couldn't connect on the phone with most surveyors). When I was brought to the Chester County probation department on March 19, 2008 my old neighbor at 283 Cotswold Lane, West Chester, PA 19380-Douglas Smith was in there and spoke with me.

When I talk about me not getting healthcare I needed when in excruciating pain, including me not being provided any prescription pain medicine in 2002-2003 when suffering from 2 herniated discs, 5 bulging discs and a fractured disc in my back please keep in mind that I didn't get my first inflammatory medication provided to me until after about 7 years of suffering from back injuries and being told to ask doctors for Mobic/Meloxicam (I'm not sure if the medications have a coded meaning).

I also wanted you to be aware that RJ used to work at the Bootroad/Pottstown Pike Mobil when I was a teenager. RJ has a cousin named Steve Chytla that had a girlfriend named Anna Musser. (I'm not sure if the Mobil also had an employee named Steve). I am sure Angela DiRocco got charged with DUI for hitting a curb when leaving the Mobil parking lot. I was in the car with Angela when she drove her camaro over a curb because she just picked me up from the Indian King neighborhood down the street. Angela DiRocco and Eric Frindt once painted pool balls on a hardwood floor in Angela DiRocco's parent's indoor pool/basement. Alaina DiRocco married a Kuhn and I once saw an image of Alaina's dad, Richard standing at the bottom of the Kuhn's driveway asking how I figured this out apparently referring to the word pronounced "Raccoon". Eric Lindros is a name that could have a coded meaning about doctors and lesbians. James Billotta drove the Zamboni for the Philadelphia Flyers and when I was exposing corruption to all the guests of the "State of Chester County Meeting" James Billotta asked me to move my sign farther from the country club entrance. For some reason I asked James Billotta if he was still driving the Zamboni.

I was led to believe that females I was friends with or dated, especially Jen Franz are being illegally trafficked by people including their own family. I am not accusing people, I'll let law enforcement figure out what is going on. I know one thing for sure, people tell me things trying to discredit me as crazy, cause me to falsely accuse people of things and

many other malicious reasons. More than 20 years ago I discretely received information about the way people talk about females my age that they don't recognize and I tested Jen Franz and told her a story about a copper recycling place that was supposed to turn the blowers on but didn't and the worker was complaining. I don't believe Jen Franz recognized any sexual meaning (there wasn't sexual meanings in what I said) but coincidentally started sucking my penis on a regular basis, like she is a mind controlled robot. Another time I was working at Mark Brancato's house and texted Jen Franz something that had a discrete meaning that Jen Franz doesn't recognize and she responded exactly the way I was expecting a response from a mind controlled sex spy (Jen was using the word "entail" and I was told "tail" is a word used to talk about female's vaginas). Jen Franz never performed a sex act on me consistent with the communication.

Jen Franz got pregnant in 2008 as she was on the same birth control she had been on for years. If Jen Franz is as bad of a trafficking victim as I was led to believe she was a miracle worker would have implanted an egg in Jen Franz without her knowing so she got pregnant by me and probably had the best chance she'd get to escape coercive human traffickers pretending she is working with schemes she is really not working with. There was information in the gynecologist's office waiting room I went to once with Jen Franz indicating to me that the secret information being provided to me was true and Jen Franz is a trafficking victim without knowledge she is being trafficked (illegally).

I'm not sure if my ex-girlfriend Christina DiRocco is a victim of illegal trafficking, I just know our favorite restaurant to go to together (just the two of us) was Red Lobster. I now live in Linda Lauby's old house and people wonder why I am here.

Jeff is another reason I may be here. When I was 16 years old me and my friends called our group "Sessions". Jeff Sessions was once the Attorney General. The state of Pennsylvania got law enforcement in way too much trouble for law enforcement to be able to admit how corrupt law enforcement is (my police and medical records don't add up to anything but a government conspiracy to kill me and they think they can hide behind "State Secrets Privileges"). Jeff Cruden's name has a meaning in Pennsylvania corruption that involves spying with Dennis's daughter, Laura Polini. Jeff Bole (pronounced "Bow") is a landscaping customer I had in West Chester, PA. I have never once communicated about a "Jeff Bowl". In 2004 Jeff Bole hired me to mulch his property (a spring clean-up) and cut a tree down. Mulch is ground up wood and the tree that I agreed to cut down was on the right side of Jeff's house, had roots and grew towards the sun. I accepted the landscaping job and then was involuntarily committed to the Horsham Clinic (pronounced whore-sham clinic) until Jen Franz picked me up there (They made me watch "Pay It Forward" and "Men of Honor" at the Horsham Clinic as people discretely continued to try and get me to help law enforcement). I've never once communicated about anything called a "whore-sham" clinic. I once went to the Chester County Hospital to visit someone and Jeff Bole was there pushing a stretcher (stretch is the name for Todd because of Todd Tryon). One day here in the Outer Banks I had to take one of my kids to the Surf Pediatrics Office where Todd Feltz works and Heather from the Holly Trail bus stop (Joe's wife) was there with her son Drew. I also once saw Joanne Hennelly (jeff bole's neighbor) working at the Chester County hospital reception desk (They both lived in Charter Chase).

Names like Neal or Niel have a meaning to me that involves a scheme getting me on my knee asking a lesbian to marry me. Corruption is trying to get me involved with sex scandals to smear my name since I don't break the law.

The Southern Shores Boat Club Parade of Lights Best In Show Awards all are names I associate with corruption and sex related schemes. The 2018 winner "Christopher Norah" is the name of Chris Franz and his ex-wife, Nora. There is a female that works at Kitty Hawk Elementary School that looks like Nora. I was told Nora said Chris likes watching another guy have sex with her. When Jen Franz won the Citadel Heart of Learning Award at Starkweather Elementary School (Jeff was a speaker) Jen's family arranged to drive us to the award ceremony where we got to drink free alcohol and dropped us off at our home where Chris Franz and Ana Gonzales were there because they were watching our kids (Jeff Ulmer hired Jen Franz at West Chester Area School District). Chris obviously wanted to be asked to spend the night at our house as he was talking about the couches being comfortable.
