Elizabeth,

I hope you are doing good.

I'm sorry that Southern Shores has employees that characterize me as a nuisance when communicating about me as evidenced in the attached text message. Unfortunately, after legal review of the evidence, a nuisance, which is defined as something (as an act, object or practice) that invades or interferes with another's rights or interests (as the use or enjoyment of property) by being offensive, annoying, dangerous, obstructive, or unhealthful is the way to characterize government employees and council members that violate property owner's rights without due process.

Since I have proven Southern Shores, especially Wes Haskett have violated all of Southern Shores property owners due process rights, especially mine, the correct person to characterize as a nuisance would be the person/people illegally interfering with Southern Shores property owners rights...and not the person asking the questions. Meaning, either the person calling me a nuisance is dangerously incompetent and displaying a psychological disorder called "projection" where the person unconsciously displaces their negative attributes upon other people as a mental defense mechanism or nuisance is coded communication that may be indicative of a scheme to discriminate and ridicule someone to cause psychological harm intended to cause the person to be found hanging from a noose.

Unfortunately for psychopaths that work for the government and intentionally violate civilian's rights to cause psychological suffering, law enforcement is already aware that disturbing information was found typed into a computer I owned about 23 years ago talking about manipulating people to kill themselves (prior to me nearly dying and several people very close to me killing themselves one way or another).
