I believe the Kitty Hawk fire department is hiding an arson. The Kitty Hawk fire department's fire report also contains false information. The fire report claims they were fighting an "offensive fire" until it was determined the occupants were out. The fire fighters intentionally let Mike Meredith's house fire burn for a long time without spraying any water on the fire. Mike and Lea Meredith banged on my door yelling that my family had to leave our house. After we left our house all the neighbors and firefighters clearly saw Lea and Mike Meredith and were talking to them as the fire fighters allowed the house to burn (Lea Meredith was also screaming so everyone noticed her). I moved my family to the Vista Lane cul-de-sac so a firetruck was between my family and the fire. After the fire I saw 2 bullets on my property and provided the FBI pictures. My family was forced to leave 4809 Vista Lane and almost hit with at least 1 bullet.

I do not appreciate the fire department hindering my investigation. I also believe the fire department is creating more legal problems for Kitty Hawk by not providing me the information I am asking for. The way I see things is the FBI has to investigate the 4805 Vista Lane fire as an attempted murder crime.
