Dear Dan:

The streets in the 2024 Street Project are Sanburnol Drive (AKA 85th Ave.NE), Elm Drive NE, and 83rd Avenue NE (between University Service Drive and Terrace Road). The project also includes a short segment of University Service Drive that is entirely in the City of Blaine.

Bids were opened for the Project on January 30, 2024. The bid amounts are higher than the amounts estimated as part of the Feasibility Report for the Project. Below are the results of the Bids received.

No action regarding the bids is necessary at this time. The next step in the process for the street project is to prepare for an assessment hearing. We have updated the estimated total project cost for the street project based on the low bid received from North Valley, Inc.

Based on the low bid, the current total project cost estimate for the street project is \$1,363,040. The current estimated amount to be assessed is \$251,983. These numbers are about 15% higher than the estimated costs presented in the Feasibility Report for the project.

At this time, we request that the council declare the amount to be assessed and order preparation of a final assessment roll. This action should include a Resolution.

The council can receive the Final Assessment Roll on February 20th. The Assessment Hearing can be held on March 18th. Contract Award can take place after the Assessment Hearing.
