ORDINANCE NO. 420-2025 (2025-2026 APPROPRIATIONS)

AN ORDINANCE, TO BE TERMED THE ANNUAL APPROPRIATION ORDINANCE OF THE CITY OF STAR, IDAHO, FOR THE FISCAL YEAR COMMENCING OCTOBER 1, 2025, AND ENDING ON SEPTEMBER 30, 2026, APPROPRIATING SUMS OF MONEY IN THE AGGREGATE AMOUNT OF \$26,559,539.00 TO DEFRAY ALL NECESSARY EXPENSES AND LIABILITIES OF THE CITY OF STAR FOR SAID FISCAL YEAR; SPECIFYING THE OBJECT AND PURPOSES FOR WHICH SUCH APPROPRIATIONS ARE MADE AND THE AMOUNT APPROPRIATED FOR EACH OBJECT AND PURPOSE; AUTHORIZING THE CERTIFICATION TO THE COUNTY COMMISSIONERS OF ADA & CANYON COUNTIES, IDAHO, THE AMOUNT OF \$2,202,714.00 PROPERTY TAXES TO BE LEVIED AND ASSESSED UPON THE TAXABLE PROPERTY IN THE CITY; PROVIDING FOR THE FILING OF A COPY OF THIS ORDINANCE WITH THE OFFICE OF THE IDAHO SECRETARY OF STATE AS PROVIDED BY LAW; PROVIDING FOR PUBLICATION; AND PROVIDING AN EFFECTIVE DATE.

BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF STAR, IDAHO, as follows:

<u>Section 1:</u> The sum of \$26,559,539.00 is hereby appropriated to defray all necessary expenses and liabilities of the City of Star, Idaho, for the fiscal year commencing October 1, 2025, and ending on September 30, 2026 (the "2026 Fiscal Year").

<u>Section 2:</u> The objects and purposes for which such appropriation is made, and the amount appropriated for each object and purpose are hereby approved.

<u>Section 3:</u> The amount of **\$2,197,744.00** is hereby authorized to be certified by the City of Star to the Board of Commissioners of Ada and Canyon Counties, Idaho, in accordance with Section 30-1007, Idaho Code, to be levied and assessed as a property tax on the taxable property within the City of Star for the 2025/2026 Fiscal Year.

<u>Section 4</u>: The amount of **\$4,970.00** is hereby authorized to be certified by the City of Star to the Board of Commissioners of Ada and Canyon Counties, Idaho, in accordance with Section 60-1305, Idaho Code, to be levied and assessed as a property tax on the taxable property within the City of Star for property taxes to be collected for the 2025/2026 Fiscal Year as a result of a Tax Appeals Judgement.

<u>Section 5:</u> All Ordinances and parts of Ordinances in conflict with this Ordinance are hereby repealed.

<u>Section 6:</u> This Ordinance shall be published once in full in the official newspaper of the City and shall take effect and be in force from and after its passage, approval, and publication.
