The reason for this overuse was due to a outdoor water faucet breaking while we were away for the weekend for my nephew's wedding. The water line that broke was down by our garden. We have lots of grapes in our garden and i believe it was broken by elk that frequent our property and do try to get at the grapes through the garden fence.

When we arrived home on Sunday, October 5th, I immediately saw the water spraying up from the broken pipe, and went and shut off the water to that line, and with it, the other outdoor water spickets that I usually shut off for the winter. The leak stopped immediately. I would very much appreciate any consideration of adjusting our water bill for this leak event.

**Good Morning,**

We are writing to inform you that your water meter reading for this billing period appears unusually high. We recommend checking for possible leaks that could be contributing to the increased usage.

Please inspect your home for any dripping faucets, running toilets, or other signs of a leak. A helpful method is to take a meter reading when all residents are away and no appliances are running for an extended period. If the meter shows movement during that time, it may indicate a leak in your private water line.

Please note the City does not have records indicating how private water lines are routed from the meter to your home, which may make locating a leak more challenging.

If a leak is discovered and repaired, you may request an adjustment to your bill. The City Council allows **one** adjustment within a **five-year period**. To request this, please submit a written statement including the date the leak was discovered, the date it was repaired, and any relevant details. This request must be received within **30 days** of the date of this notice.

If the City Council determines an adjustment is warranted, your bill will be recalculated based on your average water usage for a comparable billing period. You will then be charged **\$0.49 per 100 cubic feet** for water used in excess of that average.


