MUNICIPAL COURT REPORT

Unfortunately, I am unable to attend the city council session on July 16, 2024 due to a prior obligation in Oregon City Municipal Court. The municipal court continues to operate very efficiently. I continue to be proud of the work we have accomplish and the level of service the court provides to the citizens.

In the last fiscal year, the number of cases prosecuted, both crimes and violations, increased as shown below. However, the revenue for the cases went down. I do not have an explanation for the reduction, but I will be reviewing the data to see if there is an explanation.

The highest number of criminal cases prosecuted in the last two years were driving offenses, namely Driving Under the Influence of Intoxicants (DUII), Driving While Suspended, and Reckless Driving.

Lucy Heil, our longest standing defense attorney, is leaving this month. She has been a very valuable member of the team and provided excellent defense services for the defendants prosecuted in the court. Lance Quaranto will be taking over her caseload. He worked for the court a few years ago and I expect a smooth transition.
