#### 12. NEW BUSINESS

A. Consideration to Approve Resolution 04.25.01 - Designating Specific 2024 Excess Funds to be Transferred to Specific 2025 Budget Funds

Resolution 04.25.01 designates funds that were budgeted in 2024 and not spent due to the inability to execute projects or purchases to be completed in 2024. The 2024 funds will be moved to the 2025 budget.
