A RESOLUTION BY THE MAYOR AND CITY COUNCIL OF THE CITY OF STONECREST, GEORGIA AUTHORIZING THE EXECUTION OF THE 2026 STREET RESURFACING PROJECT CONTRACT WITH DCBC, LLC FOR AN AMOUNT NOT TO EXCEED THREE MILLION FORTY THOUSAND FIVE HUNDERED AND EIGHTY HUNDRED DOLLARS AND 98/100 CENTS (\$3,040,580.98); AND FOR OTHER PURPOSES.

WHEREAS, the City of Stonecrest, Georgia (the “City”) is a municipal corporation duly organized and existing under the laws of the State of Georgia, and is charged with providing public services to its residents; and

WHEREAS, the City wishes to enter into a contract with DCBC, LLC (the "Contractor"), a corporation created and existing under the laws of the State of Georgia for the resurfacing of certain municipal streets within the City of Stonecrest (“Contract”); and

WHEREAS, the Contract shall be governed by the law of the State of Georgia, exclusive of its choice of law provisions; and

WHEREAS, any contract for work on all or part of the municipal road system shall be in writing and be approved by resolution which shall be entered on the minutes of such municipality pursuant to O.C.G.A. § 32-4-111; and

23 **WHEREAS**, pursuant to O.C.G.A. § 32-4-118 where a contract has been let for bid, a
24 municipality, by resolution entered in its minutes, shall award the contract to the lowest dependable
25 bidder; and

26 **WHEREAS**, the City advertised for the 2026 Street Resurfacing Project; and

27 **WHEREAS**, following a review and evaluation of the proposals submitted in response to
28 the solicitation, DCBC, LLC was determined to be one of the most responsive and responsible
29 offerors; and

30 **WHEREAS**, the City and the Contractor hereby agree the Contractor will be responsible
31 for the resurfacing of certain municipal streets within the City ("Project"); and

32 **WHEREAS**, the total cost of the Project shall not exceed THREE MILLION FORTY
33 THOUSAND FIVE HUNDERED AND EIGHTY HUNDRED DOLLARS AND 98/100 CENTS
34 (\$3,040,580.98); and

35 **WHEREAS**, The Contractor shall perform and complete its duties under the Contract.

36 **NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF STONECREST,**
37 **GEORGIA, HEREBY RESOLVES**, that the Mayor, on behalf of the City, is hereby authorized
38 to execute the contract attached hereto as Exhibit A with DCBC, LLC resurfacing of certain
39 municipal streets within the City of Stonecrest.

40 **BE IT FURTHER RESOLVED**, that the cost of the work shall not exceed THREE MILLION
41 FORTY THOUSAND FIVE HUNDERED AND EIGHTY HUNDRED DOLLARS AND 98/100
42 CENTS (\$3,040,580.98).

43 **BE IT FURTHER RESOLVED**, that the City Attorney or his designee is directed to negotiate,
44 prepare, and/or review the contract attached in Exhibit A, to affect the intent of this resolution
45 provided that such agreement is in compliance with the conditions set forth herein.

46 **BE IT FURTHER RESOLVED**, that the agreement will not become binding upon the City and
47 the City will incur no obligation or liability under it until it has been executed by the Mayor,
48 attested to by the City Clerk and approved by the City Attorney as to form.

49 **BE IT FURTHER RESOLVED**, to the extent any portion of this Resolution is declared to be
50 invalid, unenforceable, or nonbinding, that shall not affect the remaining portions of this
51 Resolution.

52 **BE IT FURTHER RESOLVED**, all City resolutions are hereby repealed to the extent they are
53 inconsistent with this Resolution.

54 **BE IT FINALLY RESOLVED**, this Resolution shall take effect immediately.
