I. CALL TO ORDER: George Turner, Mayor Pro-Tem

The meeting began at 6:15pm.

- V. APPROVAL OF THE AGENDA

There was a request to remove the proclamation for National Service Dog Month from this agenda and add it to the October City Council meeting agenda.

Motion – made by Councilmember Tammy Grimes to approve the September 22, 2025, City Council Meeting agenda with the stated changes. Second by Councilmember Alecia Washington.

Motion passed unanimously.

VI. REVIEW AND APPROVAL OF MINUTES

a. Approval of Meeting Minutes - City Council Meeting, August 25, 2025

Motion – made by Councilmember Tara Graves to approve the meeting minutes from the August 25, 2025, City Council Meeting. Second by Councilmember Tammy Grimes. **Motion passed unanimously.**

VII. PUBLIC COMMENTS

Citizens wishing to make a public comment may do so in person. Citizens may also submit public comments via email to cityclerk@stonecrestga.gov by 2 pm on the day of the meeting to be read by the City Clerk.

All members of the public wishing to address the City Council shall submit their name and the topic of their comments to the city clerk prior to the start of any meeting held by the City Council. There is a three (3) minute time limit for each speaker submitting or reading a public comment. Individuals will be held to established time limits.

<u>Faye Coffield</u> – Spoke on presentation given by New Birth regarding new development. Expressed concerns about the new housing development being built off Rocksprings Rd. Spoke on homelessness issue that is happening on Panola Rd. She hopes those who are up for reelection are ready to answer the 3 following questions: What have you done? What are you doing? What will you do to keep your campaign promises?

<u>Renee Cail</u> - Requesting that when land developers want to change anything pertaining to zoning laws that the City of Stonecrest takes a closer look at what they are doing before allowing them to do so. Suggests that the city be more mindful of the ways that the community will be affected by those changes.

<u>Rosa Bell</u> - Belmont Hills resident where there was a shooting that took place early September. She wanted to thank the police officers that came out to service the community in a timely fashion, commending them on their promptness, respect, and professionalism.

<u>Donna Priest Brown-(email)</u> - Would like thorough research on the data centers and how they will impact the community before allowing them into DeKalb County. Stated there are some unique challenges and opportunities that should be understood and suggest a community engagement session to review findings and proposed conditions. Also requested adopting clear performance standards in any ordinance or text amendment, including enforceable limits for noise, stormwater, buffers, and generator operations.

Councilman Terry Fye gave a response to Mrs. Bell's public comment.

XI. REPORTS & PRESENTATIONS

- a. Proclamation National Service Dog Month Tammy Grimes, District 5 Councilmember
 This item was removed from the agenda.
- **b.** Proclamation Collard Green Festival Mayor Pro Tem George Turner

Mayor Pro Tem Turner invited all to attend the upcoming Collard Green Festival, scheduled to take place on Saturday, September 27th from 12pm-7pm, at the First Afrikan Church, 5197 Salem Road, Stonecrest, Ga 30038. A summary of the proclamation was also read by Mayor Pro Tem Turner.

XII. OLD BUSINESS

a. For Decision - Ordinance for Amendment to the Charter of the City of Stonecrest, 2nd Read - *Terry Fye, District 2 Councilmember*

Presentation was given by Councilmember Terry Fye giving an overview and stating that this amendment will change the charter requirement under Section 3.12. The city would be able to hire a contractor or FTE to serve as Internal Auditor and it would also amend the requirements to hear the auditor's requirements not less than biannually.

2nd read of the preamble was given by the City Clerk.

Motion – made by Councilmember Terry Fye to approve the Ordinance for Amendment to the Charter of the City of Stonecrest, 2nd Read. Second by Councilmember Tara Graves. **Motion passed unanimously.**

b. For Decision - Ordinance for Personnel Adjustment, 2nd Read - City Manager Gia Scruggs

The presentation was given by City Manager Gia Scruggs, stating that the purpose of this ordinance is to reclassify, create and fund positions to further the operations of the city. This request is for the newly requested or created positions of: Assistant Human Resources Director, Facilities Operations Coordinator and Clerk of Court. There is also a request for reclassification & creation of the following positions: Purchasing Specialist 1, Purchasing Specialist 2, Purchasing Specialist 3, Revenue Specialist 1, Revenue Specialist 2 & Revenue Specialist 3. In addition, there is a request to convert two Part-Time Park Ambassador positions to one Full-Time Park Ambassador position. The funding for these positions is shown in the budget adjustment.

2nd read of the preamble was given by the City Clerk.

Motion – made by Councilmember Tara Graves to approve the Ordinance for Personnel Adjustment, 2nd Read. Second by Councilmember Tammy Grimes. **Motion passed unanimously.**

c. For Decision - Approval of EV Charging Stations - GA Power Make Ready Program Acceptance Letter and EnviroSpark Agreement - *Michael McCoy, Deputy City Manager*

The presentation was given by Deputy City Manager Michael McCoy, recognizing the staff that helped move this project through the approval process. The city has applied for the Georgia Powers Make Ready Program, which will invest, own and maintain the make ready charging infrastructures. They will also develop the electrification infrastructure that will provide energy for the stations. To receive a \$0 out of pocket cost, the city has partnered with EnviroSpark and is recommending approval of the agreement. There will be no direct cost to the city as EnviroSpark will install chargers and maintain ongoing maintenance and support for the chargers.

Motion – made by Councilmember Tammy Grimes to approve the EV Charging Stations – GA Power Make Read Program Acceptance Letter and EnviroSpark Agreement with the amended liquidated provisions from \$150 to \$100. Second by Councilmember Alecia Washington.

Motion passed unanimously.

d. For Decision - Contract Amendment for the 2025 Street Resurfacing - *Lakeisha Gaines*, Finance Director

The presentation was led by Finance Director, Lakeisha Gaines, City Engineer, Hari Karikaran and Procurement Manager, Tanisha Boynton. The Procurement and Legal Departments have reviewed the contract amendment. The original contract had 20.37 lane miles, and this amendment will add 6.28 additional lane miles. If approved, the contractor is planning to wrap up milling for all lanes miles including additional miles by end of September, or 1st week in October. There is a budget adjustment included in this amendment that will cover the additional cost, for a total of \$324,482.04. Staff evaluated and decided it was best to take funds from sidewalk construction.

The preamble of the resolution was read by Mayor Cobble.

Motion – made by Mayor Pro Tem George Turner to approve the Contract Amendment for the 2025 Street Resurfacing. Second by Councilmember Tammy Grimes.

Motion passed 4-1 with Councilmember Alecia Washington voting Nay.

XIII. NEW BUSINESS

a. For Decision - Request to Apply for the Recreational Trails Program (RTP) Grant - Keira Drane, Grants Administrator

The presentation was given by Administrator Keira Drane, stating the city is seeking approval to apply for the Recreational Trails Program (RTP) Grant, which will provide funding for the walking trails program for both Fairington Park and Salem Park. The total grant award maximum amount is \$200,000 and is requiring a 20% minimum match. The resolution will be presented to council once the grant is approved and accepted.

Motion – made by Councilmember Alecia Washington to approve the Request to Apply for the Recreational Trails Program (RTP) Grant. Second by Councilmember Tara Graves. **Motion passed unanimously.**
