1	AN ORDINANCE TO AMEND CHAPTER 15 - LICENSES, PERMITS AND		
2	MISCELLANEOUS BUSINESS REGULATIONS ARTICLE XIII MULTIFAMILY		
3	RENTAL DWELLINGS OF THE CITY OF STONECREST CODE OF ORDINANCES TO		
4	ADD CERTAIN RESTRICTIONS TO LICENSE HOLDERS OF SINGLE FAMILY/		
5	MULTIFAMILY RENTAL DWELLINGS IN THE CITY OF STONECREST; TO		
6	PROVIDE FOR AN ADOPTION DATE; TO PROVIDE AN EFFECTIVE DATE; AND TO

8	WHEREAS, the City of Stonecrest, Georgia (the "City") is a municipal corporation		
9	created under the laws of the State of Georgia; and		
10	WHEREAS, the duly elected governing authority of the City is the Mayor and Council		
11	("City Council") thereof; and		
12	WHEREAS, the City Council shall have the authority to adopt and provide for the		
13	execution of such ordinances, resolutions, polices, rules, and regulations, which it shall deem		
14	necessary, expedient, or helpful for the peace, good order, protection of life and property, health,		
15	welfare, sanitation, comfort, convenience, prosperity, or well-being of the inhabitants of the City		
16	of Stonecrest and may enforce such ordinances by imposing penalties foe violation thereof; and		
17	WHEREAS, the purpose of Chapter 15 - LICENSES PERMITS AND		
18	MISCELLANEOUS BUSINESS REGULATIONS Article XIII - MULTIFAMILY RENTAL		
19	DWELLINGS of the City of Stonecrest Code of Ordinances is to protect the public health, safety,		
20	environment, and general welfare through certain regulations; and		
21	WHEREAS, the City desires to amend Chapter 15 - LICENSES PERMITS AND		
22	MISCELLANEOUS BUSINESS REGULATIONS Article XIII – MULTIFAMILY RENTAL		

23	DWELLINGS to add certain restrictions to license holders of single family/multifamily rental		
24	dwellings in the City of Stonecrest; and		
25	WHEREAS, the health, safety, and welfare of the citizens of the City will be positively		
26	impacted by the adoption of this Ordinance.		
27	NOW THEREFORE, BE IT AND IT IS HEREBY ORDAINED BY THE MAYOR		
28	AND COUNCIL OF THE CITY OF STONECREST, GEORGIA and by the authority		
29	therefore:		
30	Section 1. Chapter 15 – LICENSES PERMITS AND MISCELLANEOUS BUSINESS		
31	REGULATIONS Article XIII – SINGLE FAMILY/ MULTIFAMILY RENTAL DWELLINGS OF		
32	THE CITY OF STONECREST CODE OF ORDINANCES are hereby amended to ADD		
33	CERTAIN RESTRICTIONS TO LICENSE HOLDERS OF SINGLE FAMILY/ MULTIFAMILY		
34	RENTAL DWELLINGS IN THE CITY OF STONECREST. That the text of the Ordinance is		
35	established through the adoption of the provisions set forth in Exhibit A attached hereto and made		
36	a part by reference.		
37	Section 2. That the amended ordinance be read and codified as follows with added text in		
38	red font, bold and underlined and deleted text in red and strikethrough font.		
39	Section 3. The preamble of this Ordinance shall be considered to be and is hereby		
40	incorporated by references as if fully set out herein.		
41	Section 4. a) It is hereby declared to be the intention of the Mayor and Council that all		
42	sections, paragraphs, sentences, clauses, and phrases of this Ordinance are or were, upon their		
43	enactment, believed by the Mayor and Council to be fully valid, enforceable, and constitutional.		
44	(b) It is hereby declared to be the intention of the Mayor and Council that, to the greatest		
45	extent allowed by law, each and every section, paragraph, sentence, clause or phrase of this		
46	Ordinance is severable from every other section, paragraph, sentence, clause or phrase of this		
47	Ordinance. It is hereby further declared to be the intention of the Mayor and Council that, to the		

greatest extent allowed by law, no section, paragraph, sentence, clause or phrase of this Ordinance is mutually dependent upon any other section, paragraph, sentence, clause or phrase of this Ordinance.

- (c) In the event that any phrase, clause, sentence, paragraph or section of this Ordinance shall, for any reason whatsoever, be declared invalid, unconstitutional or otherwise unenforceable by the valid judgment or decree of any court of competent jurisdiction, it is the express intent of the Mayor and Council that such invalidity, unconstitutionality or unenforceability shall, to the greatest extent allowed by law, not render invalid, unconstitutional or otherwise unenforceable any of the remaining phrases, clauses, sentences, paragraphs or sections of the Ordinance and that, to the greatest extent allowed by law, all remaining phrases, clauses, sentences, paragraphs and sections of the Ordinance shall remain valid, constitutional, enforceable, and of full force and effect.
- <u>Section 5.</u> The City Clerk, with the concurrence of the City Attorney, is authorized to correct any scrivener's errors found in this Ordinance, including its exhibits, as enacted.
- Section 6. All ordinances and parts of ordinances in conflict herewith are hereby expressly repealed to the extent of the conflict only.
- Section 7. The effective date of this Ordinance shall be the date of its adoption by the Mayor and Council unless otherwise stated herein.
- Section 8. The Ordinance shall be codified in a manner consistent with the laws of the State of Georgia and the City of Stonecrest.
- <u>Section 9.</u> It is the intention of the governing body, and it is hereby ordained that the provisions of this Ordinance shall become and be made part of the Code of Ordinances, City of
