**AN ORDINANCE BY THE MAYOR AND COUNCIL OF THE CITY OF STONECREST,  
GEORGIA TO APPROVE SPECIAL LAND USE PERMIT 22-012 ON PARCEL NUMBER  
16 121 03 009 OF THE 2<sup>nd</sup> DISTRICT TO ALLOW THE OPERATION OF A LATE-  
NIGHT ESTABLISHMENT AT 7173 COVINGTON HWY; TO PROVIDE  
SEVERABILITY; TO PROVIDE A PENALTY; TO PROVIDE FOR REPEAL OF  
CONFLICTING ORDINANCES; TO PROVIDE FOR AN ADOPTION AND EFFECTIVE  
DATE; AND TO PROVIDE FOR OTHER LAWFUL PUPOSES.**

**WHEREAS**, the City of Stonecrest (“City”) has advertised and held a public hearing on  
January 3, 2023 in front of the City’s Planning Commission regarding SLUP 22-012, the request  
for special land use permit to allow the operation of a late-night establishment at 7173 Covington  
HWY, Stonecrest, Georgia 30058; and

**WHEREAS**, the City of Stonecrest has been vested with substantial powers, rights, and  
functions to generally regulate the use of real property for the purposes of maintain health, morals,  
safety, security, peace, and the general welfare of the City; and

**WHEREAS**, the health, safety, and welfare of the citizens of the City will be positively  
impacted by the adoption of this Ordinance.

**BE IT AND IT IS HEREBY ORDAINED BY THE MAYOR AND CITY COUNCIL  
OF THE CITY OF STONECREST, GEORGIA, as follows:**

27       **Section 1.** SLUP 22-012, a request for special land use permit to operate a short-term  
28  
29 rental at 7173 Covington HWY, Stonecrest, Georgia 30058, satisfying Section 7.4.6 of Division 4 of  
30  
31 Article 7 in Chapter 27 of the City of Stonecrest Code of Ordinances, is **APPROVED**.

33       **Section 2.** (a) It is hereby declared to be the intention of the Mayor and Council that all  
34 sections, paragraphs, sentences, clauses, and phrases of this Ordinance are or were, upon their  
35 enactment, believed by the Mayor and Council to be fully valid, enforceable and constitutional.

36 (b) It is hereby declared to be the intention of the Mayor and Council that, to the greatest extent  
37  
38 allowed by law, each and every section, paragraph, sentence, clause or phrase of this Ordinance is  
39  
40 severable from every other section, paragraph, sentence, clause or phrase of this Ordinance. It is  
41  
42 hereby further declared to be the intention of the Mayor and Council that, to the greatest extent  
43  
44 allowed by law, no section, paragraph, sentence, clause, or phrase of this Ordinance is mutually  
45  
46 dependent upon any other section, paragraph, sentence, clause, or phrase of this Ordinance.

47 (c) In the event that any phrase, clause, sentence, paragraph, or section of this Ordinance shall, for  
48 any reason whatsoever, be declared invalid, unconstitutional, or otherwise unenforceable by the  
49 valid judgment or decree of any court of competent jurisdiction, it is the express intent of the  
50 Mayor and Council that such invalidity, unconstitutionality or unenforceability shall, to the  
51 greatest extent allowed by law, not render invalid, unconstitutional or otherwise unenforceable any  
52 of the remaining phrases, clauses, sentences, paragraphs or section of the Ordinance and that, to  
53  
54 the greatest extent allowed by law, all remaining phrases, clauses, sentences, paragraphs and  
55  
56 sections of the Ordinance shall remain valid, constitutional, enforceable, and of full force and  
57  
58 effect.

60       **Section 3.** The City Clerk, with the concurrence of the City Attorney, is authorized to  
61 correct any scrivener's errors found in this Ordinance, including its exhibits, as enacted.

62           **Section 4.** All ordinances and parts of ordinances in conflict herewith are hereby  
63  
64 expressly repealed.

66           **Section 5.** The Ordinance shall be codified in a manner consistent with the laws of the  
67  
68 State of Georgia and the City of Stonecrest.

70           **Section 6.** It is the intention of the governing body, and it is hereby ordained that the  
71  
72 provisions of this Ordinance shall become and be made part of the Code of Ordinances, City of  
73  
74 Stonecrest, Georgia.
