PURPOSE: Seeking approval to award CITB-0004-25, 2025 Street Resurfacing Project to Blount Construction Company, Inc.

FACTS: Solicitation: On April 16, 2024, the City issued Construction Invitation to Bid Number CITB-0004-25, 2025 Street Resurfacing Services. The solicitation was advertised on Bidnet and the City's website. The CITB was broadcast to Three Hundred and eighty-eight (388) companies with bids due May 29, 2025. A total of eight (8) responses were received. The Procurement Department conducted an internal review of each submittal. Blount Construction Company, Inc. submitted the lowest responsive and responsible bid in response to the solicitation and its requirements. Blount Construction Companies, Inc. contract award amount shall be \$2,375,854.10. The contractor shall have one hundred and eighty (180) days from issuance of a Notice to Proceed (NTP) and Purchase Order (PO) to complete resurfacing services for the streets identified in the solicitation.

Recommendation: Based on the foregoing, it is recommended that the City Council approve and authorize the Mayor and City Clerk to execute a contract with Blount Construction Company, Inc. for a not to exceed amount of \$2,375,845.10 for 2025 Street Resurfacing Project.
