A RESOLUTION BY THE CITY COUNCIL OF STONECREST, GEORGIA ACCEPTING THE 2025 HEALTH WELLNESS GRANT FROM THE GEORGIA MUNICIPAL ASSOCIATION'S EMPLOYEE BENEFITS SERVICES LIFE INSURANCE FUND IN THE AMOUNT OF FIVE THOUSAND FIVE HUNDRED DOLLARS AND ZERO CENTS (\$5,500.00); AND FOR OTHER LAWFUL PURPOSES.

WHEREAS, the duly elected governing body of the City of Stonecrest, Georgia (the "City") is the Mayor and Stonecrest City Council ("City Council"); and

WHEREAS, GMA has paid to the City 50% of the awarded grant and will distribute the remainder in February or March 2026; and

WHEREAS, the City seeks approval to accept grant funds.

NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE CITY OF STONECREST, GEORGIA, The City Council of Stonecrest, Georgia shall accept the 2025 Health Wellness Grant from the Georgia Municipal Association's Employee Benefits Services Life Insurance Fund in the amount of FIVE THOUSAND FIVE HUNDRED DOLLARS AND ZERO CENTS (\$5,500.00).
