PURPOSE: Seeking approval to purchase new score boards for Browns Mill Community Center, Browns Mill Park and Southeast Athletics Complex from Daktronics, Inc. through Sourcwell Contract No. 030223 .

FACTS: City of Stonecrest sParks and Recreation Department is in need of new score boards at Browns Mill Community Center, Browns Mill Park and Southeast Athletic Complex. Through Cooperative Purchase, staff sought to obtain proposals under the Sourcwell Contract No. 030223, Scoreboards. Daktronics, Inc. provided a proposal to supply and install new scoreboards providing a cost-savings to the City. \$16,621.00 is needed to replace the scoreboards at Browns Mill Community Center, \$33,309.00 is needed to replace the scoreboards at Browns Mill Park, and \$50,464.00 is needed to replace the scoreboards at Southeast Athletic Complex. In accordance with the proposals received for each location, the total cost to complete this project shall be \$100,394.00. The Procurement Department and City Administration is requesting approval to issue a Purchase Order (PO) in the amount of

\$100,394.00. The Director of Finance and City Manager is seeking authorization to make payments from GL account number 300-6210-5412210, Browns Mill and GL account number 300-6210-541200, Southeast Park funds.
