PURPOSE: Seeking approval to award ITB-0013-25, Parks, Sports Fields and Trails Landscape and Maintenance Services to Yellowstone Landscape Southeast, LLC

FACTS: Solicitation: On September 5, 2025, the City issued Invitation to Bid No. ITB-0013-25, Parks, Sports Fields and Trails Landscape and Maintenance Services. The solicitation was advertised on Bidnet and the City's website. The solicitation was broadcast to nine hundred and eighty-seven (987) vendors with bids due October 16, 2025. A total of five (5) responses were received. The Procurement Department conducted an internal review of each submittal. Yellowstone Landscape Southeast, LLC submitted the lowest responsive and responsible bid in response to this solicitation and its requirements. Yellowstone Landscape Southeast, LLC award amount shall be \$281,380.00. The initial contract term shall be for one (1) year with four (4), one (1) year renewal options. **Recommendation:** Based on the foregoing, it is recommended that City
