33	Section 1.	The Code of Ordinances, City of Stonecrest, Georgia is hereby amended by

(a) It is hereby declared to be the intention of the Mayor and Council that all 51 sections, paragraphs, sentences, clauses and phrases of this Ordinance are or were, 52 upon their enactment, believed by the Mayor and Council to be fully valid, 53 enforceable and constitutional. 54 55 56 (b) It is hereby declared to be the intention of the Mayor and Council that, to the greatest extent allowed by law, each and every section, paragraph, sentence, clause 57 or phrase of this Ordinance is severable from every other section, paragraph, 58 sentence, clause or phrase of this Ordinance. It is hereby further declared to be the 59 intention of the Mayor and Council that, to the greatest extent allowed by law, no 60 section, paragraph, sentence, clause or phrase of this Ordinance is mutually 61 dependent upon any other section, paragraph, sentence, clause or phrase of this 62 Ordinance. 63 64 65 (c) In the event that any phrase, clause, sentence, paragraph or section of this Ordinance shall, for any reason whatsoever, be declared invalid, unconstitutional 66 or otherwise unenforceable by the valid judgment or decree of any court of 67 competent jurisdiction, it is the express intent of the Mayor and Council that such 68 69 invalidity, unconstitutionality or unenforceability shall, to the greatest extent allowed by law, not render invalid, unconstitutional or otherwise unenforceable any 70 71 of the remaining phrases, clauses, sentences, paragraphs or sections of the Ordinance and that, to the greatest extent allowed by law, all remaining phrases, 72 clauses, sentences, paragraphs and sections of the Ordinance shall remain valid, 73 74 constitutional, enforceable, and of full force and effect. 75 Penalties as provided in Section 1-11 of the Code of Ordinances, City of Stonecrest, 76 Section 4. 77 Georgia shall be and are hereby made applicable to this Ordinance and shall remain in full force and effect. 78 79 Section 5. All ordinances and parts of ordinances in conflict herewith are, to the extent of such 80 conflict, hereby repealed. 81 82 Section 6. The effective date of this Ordinance shall be the date of adoption unless otherwise 83 84 stated herein.
