7		APPROVAL AUTHORITY OF THE COMMUNICATION/INFORMATION
8		TECHNOLOGY DIRECTOR, AND REAL ESTATE DUE DILIGENCE;
9		ADDING CONFLICT OF INTEREST DISCLOSURES AND
10		<u>DISADVANTAGED BUSINESS ENTERPRISE GOALS AND OBJECTIVES;</u>
11		TO PROVIDE AN EFFECTIVE DATE; TO PROVIDE FOR

14	WHEREAS,	the governing authority of the City of Stonecrest ("City") is the Mayor and Council
15		thereof; and

17	WHEREAS,	pursuant to the City charter the City has the power to define, regulate, and prohibit
18		any act, practice, conduct, or use of property which is detrimental to health,
19		sanitation, cleanliness, welfare, and safety of the inhabitants of the city, and to
20		provide for the enforcement of such standards; and

22	WHEREAS,	the purpose of the Financial Management Policies Purchasing Policy ("Purchasing
23		Policy") is to state the City's position regarding the responsibility and authority for
24		the acquisition and contracting for Goods, Services, Professional Services, Real
25		Estate, and Capital Assets; and

27	WHEREAS,	the City desires to amend Chapter 2(Administration) Article VI(Finance) Division
28		2(Purchasing) Section 2-261(Purchasing Card Policy) to provide updates and input
29		new language as needed.

31		IT IS HEREBY ORDAINED BY THE MAYOR AND COUNCIL OF THE
32	CITY OF ST	ONECREST, GEORGIA, and by the authority thereof:

34	Section 1.	The City of Stonecrest Purchasing Policy is hereby amended by adopting the
35		provisions set forth in Exhibit A attached hereto and made a part by reference.
