All members were present with Mayor Cobble virtual and Councilmember Graves absent.

a. For Discussion/Public Hearing - 2024 Proposed Millage Rate - *Eric Hawkins, Revenue Manager*

Presentation by Eric Hawkins, Revenue Manager, seeking approval of the adoption of the 2024 Millage Rate. There was a review of the Taxpayer Bill of Rights, 2024 City Digest Requirements, Millage & Rollback Rate, Notice of Property Tax Increase, Computation of Millage, Current Tax Digest & 5 Year History of Levy. This is the 2nd public hearing and the final public meeting and millage adoption will take place on June 26th at 6:00pm.

The public is asked to direct all questions concerning the proposed millage rate the City Mayor, City Manager, or councilmember.

Motion – made by Councilmember Terry Fye to open public hearing for the 2024 Proposed Millage Rate. Seconded by Councilmember Tammy Grimes. Motion passed 4-0 with Councilmember Tara Graves being absent.

Motion – made by Councilmember Terry Fye to close the public hearing for the 2024 Proposed Millage Rate. Seconded by Councilmember Tammy Grimes. **Motion passed 4-0 with Councilmember Tara Graves being absent.**

Mr. Hawkins stated the city is not levying a property tax increase and the millage rate will remain 1.257, which is the same as 2023. Mayor Cobble also noted this is the third year the city has kept the millage rate the same and maintained 1.257 in 2022, 2023 and 2024.
