A RESOLUTION BY THE MAYOR AND CITY COUNCIL OF THE CITY OF STONECREST, GEORGIA TO RATIFY SERVICES RENDERED IN CONNECTION WITH THE PROFESSIONAL SERVICES CONTRACT FOR ARMED SECURITY SERVICES FOR CITY HALL AND BROWNS MILL RECREATION CENTER ("CONTRACT") WITH DYNAMIC SECURITY INC.; AUTHORIZING THE MAYOR TO EXECUTE A CONTRACT EXTENSION THROUGH AUGUST 31, 2024; AND FOR OTHER PURPOSES.

WHEREAS, the City of Stonecrest ("City") entered into a Professional Services Contract for Armed Security Services for City Hall and Browns Mill Recreation Center, with Dynamic Security Inc. ("Dynamic") on June 28, 2023 (the "Contract"); and

WHEREAS, the Initial Term of the Contract ended on December 31, 2023; and

WHEREAS, it is necessary to waive the requirements of the City's Procurement Policy to timely meet the requirements of this resolution; and

WHEREAS, the Contract expired before legislation was submitted to extend and Dynamic continues to provide services to the City; and

WHEREAS, Dynamic has performed all services satisfactorily under the Contract; and WHEREAS, the City desires to extend the Contract retroactively beginning on January 1, 2024 and ending on August 31, 2024; and

WHEREAS, the City desires to ratify any services rendered by Dynamic from January 1, 2024 through August 31, 2024; and

WHEREAS, Dynamic continues to provide services to the City and satisfactorily perform under the Contract; and

WHEREAS, the City Manager and city staff recommend an extension of the Contract and ratifying services from January 1, 2024 through August 31, 2024.

THEREFORE, BE IT AND IT IS HEREBY RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF STONECREST, GEORGIA that the Mayor, is authorized to extend the Professional Services Contract for Armed Security Services for City Hall and Browns Mill Recreation Center with Dynamic Security Inc., retroactively effective January 1, 2024 through August 31, 2024.

BE IT FURTHER RESOLVED any services provided under the Professional Services Contract for Armed Security Services for City Hall and Browns Mill Recreation Center, with Dynamic Security Inc. from January 1, 2024 through August 31, 2024 are hereby ratified.

BE IT FURTHER RESOLVED: All resolutions and parts of resolutions in conflict with this resolution are hereby waived to the extent of the conflict.

BE IT FURTHER RESOLVED: The City Manager or her designee, in consultation with the City Attorney, is directed to prepare all appropriate documents.

BE IT FINALLY RESOLVED: The contract extension will not become binding on the City and the City will incur no obligation or liability under the same until an amendment has been executed by the Mayor and delivered to Dynamic Security Inc.
