PURPOSE: Seeking approval to purchase two (2) generators from Energy Systems Southeast, LLC (EESE) through a Cooperative Purchase under Sourcewell Contract No. 092222-GNR.

FACTS: City Hall and Browns Mills Recreation Center are in need of generators to address potential power outages and maintain operations during inclement weather events. The Procurement Department and City Administration is requesting approval to purchase two (2) generators from Energy Systems Southeast, LLC through Sourcewell Contract Number 092222-GNR, Electrical Energy Power Generation Equipment. Through this Cooperative Purchase, the City is receiving a discount on the cost of the generators which includes installation cost. The generator and installation cost for City Hall is \$439,400.00. The generator and installation cost for Browns Mills Recreation Center is \$176,925.00. The total not to exceed amount for both generators is \$616,325.00. The Procurement Department and City Administration is requesting approval to issue a Purchase Orders (PO) for each location. The funding source is fund balance and the
