PURPOSE: To approve an subrecipient agreement between DeKalb County and the City to allow the City to receive Community Development Block Grant (CDBG) for the fairington road sidewalk project.

FACTS: On April 8, 2024, City of Stonecrest applied for a Community Block Grant (CDBG) for construction of Fairington Road Sidewalk. The City received an approval letter from Dealb County Community Development Department on January 6, 2025 for a Community Block Grant (CDBG) for an award amount of \$500,000. The CDBG funds will be used to complete the Fairington road sidewalk project. Staff is requesting City Council approval to accept the subreceipient agreement CDBG grant and associated funds. Staff is requesting authorization to allow the Mayor and City Clerk to execute the subrecipient agreement. Upon execution of the subreceipient agreement, staff will proceed with releasing and Invitation to Bid (ITB) to obtain bids from the contractors with the hopes of awarding a contract to the

lowest, responsive and responsible bidder to complete this project. The engineering design phase for the sidewalk has already been completed and GDOT Encroachment permit have been obtained.
