#### Section 1. SERVICES/SCOPE OF WORK

EXHIBIT A entitled SERVICES/SCOPE OF WORK is hereby amended by adding Subsection 5) and Subsection 6) to Section 4.0. The new subsections shall read as follows:

- 5) Trash and debris shall be removed from Southeast Complex, Browns Mill Complex, Panola Shoals Trailhead, Fairington Park, Salem Park, Everett Park, Gregory Mosley Park.
- 6) COVID cleaning and Sanitization of Suite 250 at 3120 Stonecrest Blvd, Stonecrest, GA 30038 (City Hall).

## Section 2. Exhibit B

Exhibit B entitled COST PROPOSAL is hereby stricken and replaced with the Exhibit B attached hereto and incorporated herein.

## Section 3. Deletion of Exhibits

Upon the date of execution of the Agreement, the parties hereto agree to delete the current Exhibit B, in its entirety, and replace it with a new Exhibit B attached hereto and incorporated by reference herein.

## Section 4. COST PROPOSAL

That any reference or mention to a COST PROPOSAL or costs for services in the current contract be replaced with "Exhibit B" COST PROPOSAL.

## Section 5. Modification of Contract

Except as expressly amended herein or as necessary to carry out the terms of this Amendment, all other terms and conditions of the Agreement shall remain in full force and effect.

## Section 6. Entirety

This Amendment and any exhibits attached hereto are hereby incorporated into the Agreement and together herewith they contain the entire Agreement between the parties as to the matters contained therein. Any oral representations or modifications concerning this Agreement shall be of no force and effect.

## Section 7. Counterparts

This Amendment may be executed in multiple counterparts, each of which shall constitute the original, but all of which taken together shall constitute one and the same Amendment. PDF signatures shall constitute original signatures.

#### **Section 8. Effective Date**

That the Amendment will become effective 15 days after the Execution Date.
