23 of slow deterioration on Main Street. Would like for the Lawn on Main to be how it was in the past very  
24 alive and thriving. There needs to be something done about the empty buildings on Main Street.

26 **Citizen Comment 2: Dave Thomas** – Gave compliments to Councilmember Marianos attire. Is in  
27 approval of the Mardi Gras event. The Lawn on Main is just sitting there. There were table talks –  
28 motivated people to come to Stone Mountain. Need signs on the streets to advertise the city.

37 support of mixed use development. Need to get vacant buildings taken care of. Caboose is falling apart.

39 **Citizen Comment 6: Andrew Zonneveld** – voiced concerns of 978 Main Street. Rejects the Stone  
40 Mountain Cemetery as a tourist attraction. Mentioned John B. Gordon. Wants to remove the racist  
41 monument.

44 to give information to the operator. Too many break-ins are occurring and there are still problems in  
45 Garden Walk.
