6 **A RESOLUTION BY THE CITY OF STONE MOUNTAIN, GEORGIA APPOINTING**
7 **DEKALB COUNTY BOARD OF REGISTRATIONS AND ELECTIONS TO CONDUCT THE**
8 **CITY OF STONE MOUNTAIN 2025 GENERAL MUNICIPAL ELECTION HELD ON**
9 **NOVEMBER 4, 2025.**

12 **WHEREAS,** the City of Stone Mountain, Georgia (the "City") in accordance with O.C.G.A. §
13 21-2-133 will hold a General Municipal Election on Tuesday, November 4, 2025 ("General Election");
14 and

15 **WHEREAS,** the Stone Mountain City Council is hereby in agreement that it would
16 be in the best interest of its citizens, pursuant to O.C.G.A. Section 21-2-45 (c), to allow the
17 DeKalb County Board of Registrations and Elections staff equipment and expertise to conduct
18 the City of Stone Mountain 2025 Elections; and

19 **WHEREAS,** the City and DeKalb County executed an Intergovernmental Agreement
20 for the provision of Election Services between Dekalb County and the City of
21 Stone Mountain (“IGA”); and

22 **WHEREAS,** the City wishes to execute an agreement in conjunction with the IGA to allow
23 the DeKalb County Board of Registrations and Elections to conduct the Elections; and

24 **WHEREAS,** Individual duties and responsibilities of both the City and DeKalb County
25 staff shall be set forth in more detail in the IGA; and

26 **WHEREAS,** the City agrees to pay all costs associated with such Elections in a manner
27 provided in the IGA.

NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE CITY OF
STONE MOUNTAIN, GEORGIA,

SECTION 1 That in accordance with O.C.G.A. §21-2-45(c) the City is authorized to enter
into an agreement appointing DeKalb County Board of Registrations and Elections to Conduct
the City of Stone Mountain November 4, 2025 General Municipal Election.

SECTION 2 That the City Attorney is hereby directed to prepare an agreement with
DeKalb County Board of Registrations and Elections for execution by the City Clerk in
a substantially similar form to the agreement set forth in **Exhibit A** attached hereto.

SECTION 3 That the City shall pay DeKalb County all costs incurred in conducting the
General Municipal Election specifically enumerated in the Intergovernmental Agreement for
the provision of Election services between Dekalb County and the City of Stone Mountain
attached hereto as **Exhibit B**.

SECTION 4 That the agreement with DeKalb County Board of Registrations and
Elections shall not become binding on the City and the City shall incur no liability upon same
until such agreement has been executed by the Municipal Clerk and delivered to the contracting
party.
