**Citizen Comment 3: Ms. Thomas –** Thanked the Council for advancing the pavement initiative, noting that work on Rockborough East Court was completed over the weekend, with West Court scheduled next; acknowledged and appreciated the increased police presence in the area; inquired about updates on Baptist Lawn, noting confusion following rumors of a hotel development despite the Council's previous vote to move forward with the LCI proposal.
