24 Mayor Jones led the Pledge of Allegiance, followed by the Invocation

26 **IV. Citizen Comments/Including comments from public/stakeholders**

27
28 **Citizen Comment 1: Joan Monroe** – Expressed that she recently reviewed a report presented
29 to the City Commission reflecting population decline and reduced revenue for the City. She
30 expressed concern that, despite limited financial resources, additional staff are being hired to
31 prepare reports she believes may be inaccurate and encouraged the City to conduct
32 independent audits and exercise fiscal restraint. She also raised concerns regarding relevant
33 information not being included on Planning Committee meeting agendas.

34
35 **Citizen Comment 2: Kay Nunez** – She expressed support for the agenda item regarding the
36 installation of “No parking” signs, emphasizing that their placement is important for the safety of
37 emergency vehicles and neighbors exiting their homes.

38
39 **Citizen Comment 3: Ms. Thomas** – Raised concerns regarding A&S Paving, stating that
40 property damage had occurred. She also noted that the court on Rockborough Terrace was
41 paved but is already cracked. She requested that the City Manager visit the site; the City
42 Manager indicated that an engineer would be brought out, but this has not yet occurred. Further
43 stated that there is conflicting information between the Comprehensive Advisory Committee and
44 the Planning Commission regarding the ability to add three additional seats. She referenced the
45 LCI study, indicating that Rockborough was excluded and that residents’ voices should be

46 heard, stated that planning is out of compliance, and inquired about when the 2024 audit will be
47 presented.

49 **Citizen Comment 4: Hawa Aden** – A resident reported property damage caused by A&S
50 Paving and requested a meeting with the City Manager after being informed the damage would
51 be repaired, but receiving no further updates.

- 92 2. Planning Commission
93

94 Ms. Tamayah Huff provided an update from the Planning Commission, announcing that the initial public
95 hearing for the Comprehensive Plan will be held on January 20, 2026, to introduce the original 2021
96 plan and review procedures and processes. She also noted that a draft Comprehensive Plan calendar,
97 including the stakeholder meeting schedule, will be released and posted on the City's website.

98 Additionally, the Planning Commission is updating its bylaws to ensure compliance with zoning
99 procedures and laws.

100
101 The Mayor requested clarification regarding the addition of members to the Planning Commission,
102 stating she had been advised that some individuals were unable to participate due to not being
103 residents of the City of Stone Mountain. Ms. Huff clarified that twenty-one positions were presented to
104 Council in October and that none of the proposed members were disqualified based on residency. She
105 explained that, in accordance with DCA requirements, the commissions followed a structured process
106 to identify and recommend potential stakeholders.

107
108 **3. Historic Preservation Commission**

109
110 Ms. Tamayah Huff provided an update on the grant Memorandum of Agreement, stating that it has
111 been executed and the RFP process is underway to solicit consultants to document approximately 438
112 buildings. She noted that while some buildings may not qualify, many are near the 40-year threshold
113 and are expected to be included in the historic preservation review in accordance with the State's
114 analysis.

116 **IX. Staff Reports**

117 **1. Public Safety – Reports/Updates given by Police Chief James Westerfield**

118 Chief James Westerfield presented an overview of recent activity and crime statistics as outlined in the
119 agenda packet. He also addressed Council questions regarding seasonal increases in certain crimes,
120 including domestic incidents and package theft. He advised residents to coordinate with neighbors and
121 to schedule package deliveries when they are home.

123 **X. City Managers Report**

124
125 **1. Operations Report - Interim City Manager Maggie Dimov**

126
127 The Interim City Manager invited Police Chief James Westerfield to the podium to present the
128 Employee of the Month and Officer of the Quarter awards to Officer Voy.

129 Interim City Manager Maggie Dimov then reviewed the Operations Report, highlighting key staff
130 accomplishments and providing updates on several capital projects, including the successful
131 completion of the Kaboom Project by Public Works. She also reported that a pipe leak near the VFW
132 has been repaired, City Hall's parking lot and HVAC system are being addressed, and the stormwater
133 project is underway with permits currently being prepared.

134 Council Member Marianos requested an update on the potholes along James B. River Memorial. It was
135 confirmed that a temporary repair has been completed, with full paving scheduled for next year, and
136 that further consultation with contractors will take place regarding the project.
