ORDINANCE LEVYING DECREASED MILLAGE RATES FOR THE YEAR 2024 THE ST. TAMMANY PARISH CORONER.

TAMMANY HEREBY ORDAINS that in a public meeting held on <u>September 25, 2024</u>, which meeting was conducted in accordance with the Open Meetings Law and the additional requirements of Article VII, Section 23(C) of the Louisiana Constitution and R.S. 47:1705(B), that the Parish Council voted to decrease the millage rates on all taxable property shown on the official assessment roll for the year 2024, and when collected, the revenues from said taxes shall be used only for the specific purposes for which said taxes have been levied. Said millage rates are:
