ORDINANCE TO AUTHORIZE ST. TAMMANY PARISH GOVERNMENT, THROUGH THE OFFICE OF THE PARISH PRESIDENT, TO ACCEPT AN ACT OF DEDICATION AND DONATION FOR A PORTION OF ESTATES AT THE RESERVE SUBDIVISION, PHASE 1, FOR BENEFIT OF DRAINAGE IMPROVEMENTS (WARD 4, DISTRICT 10)

WHEREAS, B B Mini Storage, L.L.C. (the "Owner") is owner of a certain parcel approximately twenty feet (20') in width and running between Lonesome Road and Bayou Chinchuba in Mandeville (the "Property"); and

WHEREAS, the Property is more fully depicted as "This Drainage R.O.W. to be dedicated to St. Tammany Parish" on the Estates of Reserve, Phase 1 Subdivision Plat recorded under Map File No. 2135; and

WHEREAS, Owner has requested and Parish desires to accept the dedication and donation of the Property in consideration of the use of the Property for drainage; and

WHEREAS, there is a need and a public purpose for the acquisition of the Property for further enhancement of public drainage in the area.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS: that St. Tammany Parish Government, through the Office of the Parish President, is authorized to acquire by Act of Dedication and Donation all that certain property approximately twenty feet (20') in width and depicted as "This Drainage R.O.W. to be dedicated to St. Tammany Parish" on the Estates of Reserve, Phase 1 Subdivision Plat recorded under Map File No. 2135 (the "Property"); and

BE IT FURTHER ORDAINED: that the Office of the Parish President is hereby authorized to exercise its discretion in acquiring the Property and/or all related rights-of-way, infrastructure and/or servitudes, together with signing all documents, agreements and transactions necessary to carry out the intent of this Ordinance; and

BE IT FURTHER ORDAINED: that any and all actions previously taken by the Office of the Parish President in furtherance of the actions contemplated herein are ratified and accepted accordingly.

REPEAL: All ordinances or parts of Ordinances in conflict herewith are hereby repealed.



ORDINANCE TO AUTHORIZE ST. TAMMANY PARISH GOVERNMENT, THROUGH THE OFFICE OF THE PARISH PRESIDENT, TO ACCEPT AN ACT OF DEDICATION AND DONATION FOR A PORTION OF ESTATES AT THE RESERVE SUBDIVISION, PHASE 1, FOR BENEFIT OF DRAINAGE IMPROVEMENTS (WARD 4, DISTRICT 10)

Parish seeks authorization to accept for public use the dedication and donation of the drainage right-of-way depicted on the Estates at the Reserve, Phase 1 Subdivision Plat. The drainage parcel was intended to be donated as shown on the plat; however, the Plat's formal dedication language did not include any dedication to the public.
