Bus-Passenger (2021)

Reduce available funds from a Grant award cancelled due to cost increases, which was received to acquire a 16-passenger, 2 wheelchair space, rural transportation vehicle to be used by Council on Aging St. Tammany (COAST). Remove total funding for the vehicle, which includes \$131,702.40 from FTA, \$5,268.10 from DOTD, and \$19,973.50 from Mass Transit Funds.
