ADMINISTRATIVE COMMENT AMENDMENT NO. 9 - 2025 CAPITAL IMPROVEMENTS - MARCH 2025

SECTION I: CAPITAL IMPROVEMENTS - INFRASTRUCTURE (ROADS, BRIDGES, DRAINAGE, AND UTILITIES)

Harrison Ave. Mill & Overlay

Scope: The project consists of a 2" mill and overlay, pavement patching where necessary, and restriping along Harrison Avenue between I St. and LA59. This work will be done to improve the roadway surface and create safer driving conditions for motorists.

Status: Final design plans have been completed and project is awaiting to receive funding.

Herwig Bluff Rd. Drainage

Scope: Project to construct drainage improvements to areas upstream of the culvert crossing at Herwig Bluff Rd. This will include an additional 36" RCP (reinforced concrete pipe) to the additional culverts running underneath Herwig Bluff Rd. The purpose of this work is to allow for flow underneath Herwig Bluff Rd. to improve drainage conditions upstream of the crossing.

Status: A drainage study was performed to support adding the additional 36" RCP. Project is currently in pre-design phase.

Hoover Dr.

Status: This budget request is to secure funding to begin the design portion of the project and for construction funding.

SECTION I: CAPITAL IMPROVEMENTS - INFRASTRUCTURE (ROADS, BRIDGES, DRAINAGE, AND UTILITIES)

Little Bayou Castine Drainage

Scope: This project involves channel improvements to Little Bayou Castine, culvert improvements to efficiently convey water to Little Bayou Castine, and a pond at the end of Nelson Street. The intent is to reduce the risk of house flooding for the Woodlands Subdivision, Woodlands Terrace Subdivision, Marigny Trace Subdivision, Trailwoods Subdivision, Casa Bella Subdivision, Grand Terre Subdivision, Emerald Pines Ct., Thrush Dr., and Eola St.

Status: Project originally funded 100% by FEMA. When design and permitting were completed, the construction estimate was higher than anticipated but still showed significant benefit despite the cost increase. FEMA did not have the funding available; so, the Parish funded the difference. FEMA sent the project back through review in 2022, where the project remains and has not moved forward. This funding request will be to fund the land acquisition and remaining construction costs.
