AN ORDINANCE TO RENAME LAKE ROAD (R07F003) AS GLOCKNER ROAD  
(WARD 7, DISTRICT 7)

WHEREAS, a request was made to rename Lake Road (R07F003) as Glockner Road; and

WHEREAS, two roads in St. Tammany Parish are named Lake Road, in Madisonville and Lacombe, which leads to confusion; and

WHEREAS, St. Tammany Parish Government maintains Lake Road; and

WHEREAS, Clifford and Connie Glockner were commercial fishers who worked to protect Lake Pontchartrain from pollution and helped to found the Lake Pontchartrain Basin Foundation in 1988; and

WHEREAS, the Glockners and other environmentalists campaigned for a wildlife refuge to protect the wetlands on the north shore which resulted in the creation of the Big Branch Marsh National Wildlife Refuge, which was declared on Oct. 29, 1994.

THE PARISH OF ST. TAMMANY HEREBY ORDAINS that Lake Road (R07F003) be renamed as Glockner Road to recognize contributions of the Glockners to St. Tammany.

BE IT FURTHER ORDAINED that the Department of Public Works is directed to obtain and place the appropriate street signs to designate the road as indicated above.

REPEAL: All ordinances or parts of Ordinances in conflict herewith are hereby repealed.

SEVERABILITY: If any provision of this Ordinance shall be held to be invalid, such invalidity shall not affect other provisions herein which can be given effect without the invalid provision and to this end the provisions of this Ordinance are hereby declared to be severable.

EFFECTIVE DATE: This Ordinance shall be effective fifteen (15) days after adoption.
