RESOLUTION TO ACKNOWLEDGE THE AUTHORITY, PURSUANT TO HOME RULE CHARTER SECTIONS 1-04, 1-06, 3-01 AND 3-09, FOR ST. TAMMANY PARISH GOVERNMENT, THROUGH THE OFFICE OF THE PARISH PRESIDENT, TO EXECUTE ONE OR MORE SIDEPATH AGREEMENT(S) WITH THE LOUISIANA DEPARTMENT OF TRANSPORTATION AND DEVELOPMENT PERTAINING TO ROUNDABOUTS AT LA 1088 AT SOULT/TRINITY; LA 1088 AT FOREST BROOK; AND LA 1088 AT I-12

WHEREAS, the State of Louisiana, Department of Transportation and Development (“DOTD”) seeks to construct or have constructed roundabout intersection improvements at (1) La 1088 and Sould/Trinity; (2) La 1088 at Forest Brook Blvd.; and (3) La 1088 at I-12; and

WHEREAS, as a part of the above projects, DOTD seeks to construct certain sidewalks; and, following completion of the projects, DOTD desires, and Parish agrees to accept future maintenance obligations of the sidewalks.

THE PARISH COUNCIL OF ST. TAMMANY HEREBY RESOLVES that St. Tammany Parish Government, through the Office of the Parish President, pursuant to Home Rule Charter Sections 1-04, 1-06, 3-01 and 3-09, is authorized to enter into one or more Sidepath Agreement(s), which meets or exceeds all requirements of Louisiana law and jurisprudence, with the State of Louisiana, Department of Transportation and Development, for construction of roundabout intersection improvements at (1) La 1088 and Sould/Trinity; (2) La 1088 at Forest Brook Blvd.; and (3) La 1088 at I-12, and to take any and all actions necessary to enter into the Sidepath Agreement(s) in support of same.
