| BE IT FURTHER ORDAINED: that, following acquisition of demolition of remaining improvements on the Property, the Office of the Parish President is authorized to exercise its discretion in selling exchanging and/or disposing of the Property, together with all agreements and all transactions necessary to carry out the intent of this Ordinance; and | | | |
| BE IT FURTHER ORDAINED: that any and all actions previously taken by the Office of the Parish President in furtherance of the actions contemplated herein are ratified and accepted accordingly. | | | |
