COASTAL RESTORATION CAPITAL PROJECTS

AMENDMENT NO. 8 - 2025 CAPITAL IMPROVEMENTS - MARCH 2025

SECTION I: CAPITAL IMPROVEMENTS - INFRASTRUCTURE (ROADS, BRIDGES, DRAINAGE, AND UTILITIES)

Tchefuncte Peninsula

Scope: The Tchefuncte River Peninsula Restoration & Living Shoreline Project (Project) plans to restore the historic ridge and peninsula into Lake Pontchartrain along the eastern banks of the Tchefuncte River. This Project is Phase II of the peninsula restoration and proposes natural features along the north side (protected) of the first phase. Phase I is the Lower Tchefuncte Breakwater Project which is an armored rubble riprap breakwater that is nearing the end of the design phase, prior to entering construction.

Phase II aims to capitalize on the protection features being implemented in Phase I, by designing and permitting the following features:

- Dredging of lake and/or river sediment and beneficially placing within the proposed peninsula restoration area.
- Construction of ridges and/or mounds within the proposed peninsula restoration area.
- Living shoreline protection techniques as needed around the peninsula perimeter.
- Construction of a tidal creek and/or spring-fed estuary within the peninsula restoration area.
- Vegetative plantings within the peninsula restoration area.

Project includes design, permitting, and dredging of Lake Pontchartrain for placement within peninsula restoration area.

Status: After design phase, construction to be budgeted for ridges/mounds within peninsula area, living shoreline area, construction of estuary, and vegetative planting within peninsula area.
