- -Tanner moved to refer Ordinances for Introduction #10- through #20 to the Finance Committee, seconded by Corbin. Unanimous with three (3) absent (Rolling, Cazaubon, O'Brien).
- -Impastato asked Council if they had any further items to be pulled.
- -Cougle Appointment 3. Resolution to appoint members of the St. Tammany Parish Library Board of Control pursuant to staggered terms as required by La. R.S. 25:214(B). (Cougle) (Postponed on 03/07/2024)
- -Said there will be a substitute resolution from Councilwoman Tanner.
- -Tanner explained the substitute.

- -Emily Couvillion said that Tanner will need to make a motion to vote on the substitute, and if the substitute is approved, the Council will take nominations. Once all nominations are received, the nominations will be closed. The nominations will then layover until May and the new appointees will take office in June to allow for oaths and training.
- -Laughlin asked if Cougle wanted to speak before Tanner at the April meeting.
- -Tanner moved to refer to the full Council, seconded by Corbin. Unanimous with three (3) absent (Rolling, Cazaubon, O'Brien).
- -Impastato **28. Ordinance Calendar No. 7559** Ordinance to amend St. Tammany Parish Code of Ordinances, Part I Code of Ordinances, Chapter 2 Administration, Article III Parish Council, Sec. 2-75 Agenda format, to establish a one-minute time limitation for public comment on procedural motions to postpone any item on a Parish Council Agenda. (Laughlin/Impastato)
- -Said the sponsor should include Corbin and Phillips.
- -Laughlin explained what occurred here.
- -Corbin asked if they were limiting themselves by only including postponement.
- -Couvillion explained that in her research, she found that only the postponement is debatable.
- Corbin moved to refer to the full Council, seconded by Tanner. Unanimous with three (3) absent (Rolling, Cazaubon, O'Brien).
- -Impastato **29. Ordinance Calendar No. 7560** Ordinance to amend the Code of Ordinances of St. Tammany Parish, Louisiana, Part I, Chapter 35 Roads and Bridges, Article I, by adding Section 35 35: Directional Boring Operations, to protect underground utilities. (Cougle)
- -Grant Black gave an update on this ordinance. Some highlights included: company markers (visible labeling on vendors), potholing, dawn to dusk, jury of peers, 811 training, construction licenses, and emergency exemptions. He said they are on their fourth draft and about a week away from completion of the ordinance.
- -Cougle asked what draft is available to the public.
- -Diana Velez responded that none at the moment.
- -Cougle asked about amending the ordinance.
- -Couvillion explained that nothing has been published yet, so no need to amend.
- -Black explained that they want to make sure they are doing this correctly.
- -Laughlin asked, "if you follow the rules then you can do directional boring, correct".
- -Black responded.
- -Corbin thanked the administration for moving quickly.
- -Corbin moved to refer to the full Council, seconded by Phillips. Unanimous with three (3) absent (Rolling, Cazaubon, O'Brien).
- -Impastato **1. Resolution Council Series No. C-6909** Resolution to adopt procedures relative to the appointment of open positions to Boards or Commissions by the St. Tammany Parish Council. (Corbin/Binder)
- -Corbin explained the purpose of this resolution and gave a summary of what will occur when using this voting procedure.
- -Couvillion reminded them that there are a number of open positions, and asked them to be patient with the clerk and themselves. She said this is a learning process and it is long and tedious.

- -Laughlin asked Corbin if he wanted to move this up at the meeting.
- -Corbin said yes.
- -Cougle asked Couvillion to explain how the voting process would go.
- -Couvillion explained that everyone will get a ballot sheet and select their nominees. The clerk/administrator will record all votes on a master sheet and give the Councilmembers back their ballots. She said the Councilmembers will then read their nominees.
- -Cougle asked if they read their votes 1 through 14 or not?
- -Couvillion explained that it won't matter because the Clerk will have already recorded the votes.
- -Laughlin said this will avoid any swaying of votes.
- -Council discussion ensued.
- Couvillion also explained that this addresses lots.
- -Corbin moved to refer to the full Council, seconded by Tanner. Unanimous with three (3) absent (Rolling, Cazaubon, O'Brien).
- -Impastato **5. Resolution Council Series No. C-6913** Resolution to concur/not concur (circle one) with the Town of Pearl River annexation and rezoning of 327 acres, Pearl River, LA. Property is located on Porters River Road, South of I-59 Mobile Home Park, situation in Section(s) 13, 18, 37 Township 8 South, Range 14 & 15 East (Ward 8, District 9). (Cougle/Cooper)
- -Cougle explained that there will be a substitute resolution and went into details of the substitution.
- -Liner said that Cougle explained it correctly.
- -Cougle asked if they could give more than 3 minutes to the mayor.
- -Impastato said they could decide that at the meeting.
- -Laughlin asked how much time.
- -Cougle explained that some will be against this.
- -Laughlin asked for clarification on the merits of what they will speak about.
- -Couvillion and Cougle made comments.
- -President Cooper asked what they were voting on and clarification on this matter.
- -Discussion ensued regarding the Growth Management Agreement and the Sales tax.
- **It was explained that the annexation can occur whether the Council concurs or not.
- -Corbin moved to refer to the full Council, seconded by Tanner. Unanimous with three (3) absent (Rolling, Cazaubon, O'Brien).
- -Impastato **8. Resolution Council Series No. C-6916** Resolution authorizing the transfer of funds in escrow from the Voluntary Developmental Agreements to Capital Fund 222-4001 Economic Development Planning. (Impastato/Cooper)
- -Impastato said he was told that it should say Tanner/Cooper.
- -Tanner moved to refer to the full Council, seconded by Phillips. Unanimous with three (3) absent (Rolling, Cazaubon, O'Brien).
- -Impastato **11. Resolution Council Series No. C-6919** Resolution to initiate pilot program to identify and inspect on-site sewage disposal systems in Council Districts 1, 2, 4, 7, and 11. (Laughlin/Impastato)

- -Phillips said he wants to make sure District 5 is added.
- -Brown explained that they will divide the thousand homes among any districts that want to participate.
- -Corbin said he would like to add District 13.
- -Couvillion said this allows any Councilmember the option to opt in by contacting the Director without having to amend the resolution.
- -Corbin said he can do whatever is easier.
- -Phillips said he would like for his district to be added to the resolution.
- -Burke said he would like for District 8 to be added too.
- -Corbin moved to refer to the full Council, seconded by Tanner. Unanimous with three (3) absent (Rolling, Cazaubon, O'Brien).
- -Tanner moved to refer the remainder of agenda to the full Council, seconded by Phillips. Unanimous with three (3) absent (Rolling, Cazaubon, O'Brien).
- -There being no further business, meeting adjourned at the call of the Committee Chairman.
