**AMENDMENT NO. 21 - 2024 CAPITAL IMPROVEMENTS - MAY 2024**

**SECTION I: CAPITAL IMPROVEMENTS - INFRASTRUCTURE (ROADS, BRIDGES, DRAINAGE, AND UTILITIES)**

**CAPITAL PROJECTS - 201 - PARISHWIDE DRAINAGE**

Westwood Regional Detention Pond

Scope: Construction of a 60-acre dry detention pond in the Bayou Tete L'Ours basin to facilitate stormwater detention and better water conveyance.

Status: Project is at 95% design plans. Permit signed by PPMC sent back to the Corp for signature on March 3rd. Working on land donation as well. Requesting additional funding for construction and inspection. Amounts are based on the estimates from the consultant, Cost increase is due to inflation and rising prices. Land donation expected to finish mid-2024, with construction expected late 2024. Once construction is complete, we will plant the pond in accordance with the Corp permit requirements.
