RESOLUTION TO CONFIRM ALL PARISH COUNCIL-APPOINTED BOARDS AND COMMISSIONS COMPLY WITH TERMS OF OFFICE AND STAGGERING OF TERMS PURSUANT TO STATE LAW AND PARISH ORDINANCES.

WHEREAS, upon review of the appointment of members to boards and commissions by the Parish Council, it has become apparent that a number of appointments are not compliant with state and/or parish law relative to the terms of office of the appointed members; and,

WHEREAS, in an effort to ensure that the terms of office of all Parish Council-appointed boards and commissions are compliant with the law, the Parish Council shall endeavor to vacate and appoint any non-compliant terms of office; and,

WHEREAS, research regarding the appropriate term of office for each Parish Council-appointed board and commission has been undertaken and identified numerous boards and commissions whose appointed terms of office may be non-compliant as indicated by highlighting on the attached Exhibit "A"; and,

WHEREAS, the Parish Council has begun and shall continue to appoint members to terms of office compliant with state and/or parish law, and shall confirm that all terms of office on Parish Councilappointed boards and commissions comply with the law by December 31, 2024.

THE PARISH OF ST. TAMMANY HEREBY RESOLVES to confirm by December 31, 2024, that the terms of office for all members on all Parish Council-appointed boards and commissions comply with state and/or parish law, as indicated by Exhibit "A," attached.
