ORDINANCE TO AMEND THE 2024 CAPITAL IMPROVEMENT BUDGET AND CAPITAL ASSETS - AMENDMENT NO. 20
PARISHWIDE ROADS & DRAINAGE CAPITAL PROJECTS

SECTION I: CAPITAL IMPROVEMENTS - INFRASTRUCTURE (ROADS, BRIDGES, DRAINAGE, AND UTILITIES)

US11/Haas Rd. Intersection

Scope: The recently completed traffic study conducted at the intersection of US11 and Spiehler Rd. also looked at the intersection of US11 and Haas Rd. The final study determined that a left turn lane off of southbound US11 and a right turn lane off of northbound US11 were warranted, as well as an additional lane on Haas Rd. to create a left turn lane and thru/right turn lane onto US11, in accordance with the LADOTD Guidelines. We are now requesting funding to design the turn lanes.

Status: This budget request is to secure funding for the design of the warranted turn lanes at US11 and Haas Rd. in Slidell.
